**AFFIDAVIT FOR HOMEOWNER ELECTRICAL PERMIT**

Some provisions are:

1. That a permit must be secured before any work is started;
2. That plans for the work may be required;
3. That no work will be covered before inspection is made and approval received.

It is further agreed that the work is the sole responsibility of myself, and if upon inspection, the electrical inspector finds that the work is substandard, he may require me to engage a licensed electrical contractor at once to correct and finish the work.
