HARVEST MOON CELEBRATION – APPLICATION FOR LIQUOR LICENSE TO MLCC

The Harvest Moon Celebration is September 15-16, 2016. In order to apply for a temporary beer and wine license from the Michigan Liquor Control Commission.

RESOLVED, that the application from the Farmington Downtown Development Authority for a special license to serve alcohol on September 15-16, 2016, to be located at Riley Park, 331134 Grand River Avenue. It is the consensus of this body that the application be recommended for issuance. MOTION CARRIED, ALL AYES.

TRADEMARK SUBLICENSE AGREEMENT – MAIN STREET AMERICA/NATIONAL MAIN STREET CENTER

The National Main Street Center recently underwent a comprehensive refresh project that included the introduction of new branding graphics and requirements. As an accredited program, the Farmington DDA is entitled to make use of the Main Street America logo in accordance with guidelines. The board must first approve the sublicense agreement between it and the coordinating program, which is Main Street Oakland County.

RESOLVED, that the board authorizes the Executive Director to enter into the trademark sublicense agreement with Main Street Oakland County on behalf of the Farmington DDA. MOTION CARRIED, ALL AYES.

WORK PLAN UPDATES

Griswold reported that the initial survey for the Block Captain project is ready to go. She and President Gallagher will pass out the surveys; the Block Captains shall be charged with picking up the surveys from assigned businesses.

Skrzycki stated that marketing materials for the Harvest Moon Celebration are in production. A pancake breakfast has been added on Saturday, September 17. The pep rally is August 16; please attend if your schedule permits.

Buck shared that Innovate Farmington shall resume meeting on September 6 after a summer hiatus. The remaining meet ups in 2016 will be held at the library. September 6 is Pitch Night.

Murphy reported that Farmington Second Fridays happens on August 12 with a Beach Party theme, music by Surf Zup at Rhythmz in Riley Park and more activities at participating businesses.

Knowles reminded board members about the Downtown Master Plan Open House on Tuesday, August 9. Additionally, she informed the board that the DDA is entitled to a technical visit this year as a benefit of participation in Main Street Oakland County. Buck offer ideas such as branding, benchmarking and public art. After some discussion, board members concurred with the idea of a public art audit and plan. Knowles will confer with MSOC to determine next steps for an October or November tech visit.
