PRESENTATION OF SIX-YEAR CAPITAL IMPROVEMENT PLAN 2000-2005. City Manager Lauhoff presented the 2000-2005 Six-Year Capital Improvement Plan for Council consideration.

Discussion followed regarding proposed equipment purchases and document storage needs.

**CONSIDERATION OF RESOLUTION TO ACCESS THE OAKLAND COUNTY ENVIRONMENTAL INFRASTRUCTURE FUND.** Administration stated that in 1999 the Oakland County Board of Commissioners established an Environmental Infrastructure Fund program to provide monies to the City of Farmington to assist in addressing clean water and storm water needs. The City is eligible to receive \$42,457 each year. Administration recommended that Council adopt a resolution authorizing City administration to request reimbursement in compliance with the County's reimbursement process.
