A regular meeting of the Farmington City Council was held on February 7, 2022 at Farmington City Hall, 23600 Liberty Street, Farmington, MI. Notice of the meeting was posted in compliance with Public Act 267-1976.

The meeting was called to order at 7:00 p.m. by Mayor Bowman.

4. BOARD AND COMMISSION INTERVIEW: EMERGENCY PREPAREDNESS COMMISSION

7. DOWNTOWN DEVELOPMENT AUTHORITY REAPPOINTMENTS

Bowman also requested that two members of the DDA Board be reappointed to serve another term. LaRussa asked that term limits and length of term when appointed mid-term be reviewed.

8. APPOINTMENTS TO THE FARMINGTON HILLS INNOVATION, ENERGY AND ENVIRONMENTAL SUSTAINABILITY COMMITTEE

Late last year, the City of Farmington Hills established the Innovation, Energy and Environmental Sustainability Committee. This is a joint committee that consists of 11 members, two of which shall be Farmington residents. The focus of the committee is to enhance, advance and develop innovation, energy and environmental sustainability programs within the communities and the committee "shall expire two years from the date of adoption".

Move to appoint Farmington residents David Richardson and Nick Rudofski to the Farmington Hills Innovation, Energy and Environmental Sustainability Committee.**

9. ADOPT RESOLUTION APPROVING THE 2022 FOUNDER'S FESTIVAL

Bowman requested adoption of a resolution to allow 360 Event Productions to apply for needed road closings and temporary liquor licenses. Julie Law of 360 Productions summarized tentative plans and was available for Council questions.

Discussion about possible conflict in timing with the Farmington Road Streetscape project, adding local business participation in parade, whether fees would be waived for city venues, and what activities for teens could be added. In response to a question by Taylor, Law said that there was a lot of feedback from last year and many changes were made because of it. Taylor also requested more publicity, though Bowman listed the many media interviews she was part of for last year's event.

Move to adopt resolution approving the 2022 Founders Festival which includes approving event locations, authorizing road closures and applications for temporary liquor licenses. **
