Director Schulz advised Public Safety's involvement in these special events is usually 1-2 officers for 2 hours or less. He noted there are a number of events where their assistance is not needed.

Pastue stated that if the DDA was in agreement, he did not see any problem with moving the event to August. He stated an action will be brought back to Council to withdraw their previous approval followed by approval of the new date.
