WORK PLAN UPDATES

Installation of the Inside Out art exhibit is scheduled for March 27, 2012. We are planning 3 events while the art is on display. Activities will include a restaurant art walk, kids art crawl and adult art walk. Specifications for lawn replacement in Riley Park are complete and will be reviewed by DPW Director Kevin Gushman. Knowles acknowledged Dominic BelCastro from Luigi's for his generosity at the volunteer appreciation gathering.

Promotions Committee: The locator map update will go to print in May. The committee is brainstorming ways to engage for distribution before the event season begins.

ER Committee: A realtor came to an ER meeting and requested information on the available incentives of the DDA. We are investigating the legal ability of the DDA to underwrite the cost of a redevelopment liquor license.

Organization Committee: The Spring, 2012 Main Street Messenger is in the final editing stage and will be ready for distribution on April 24. A volunteer pep rally is scheduled for Tuesday, May 8, 2012.
