## CONSIDER APPROVAL OF TWO FLEET VEHICLES FOR PUBLIC SERVICES DEPARTMENT

Administration advised that the Public Services Department vehicle replacement schedule includes allocations for the purchase of two vehicles in the FY 2004-05 budget. Administration further advised that the purchase would be made through Oakland County's Cooperative Purchasing Program.

**RESOLUTION 11-04-266** Motion by McShane, seconded by Bush, to approve the purchase of two Public Service Department vehicles from Red Holman GMC of Westland, an authorized dealer of the Oakland County Cooperative Purchasing Program: a 2005 GMC, four-wheel drive, heavy-duty extended cab pickup truck in the amount of \$28,749 and a 2005 GMC chassis, high cube van, including specialized additional equipment, in the amount of \$29,790, for a total cost of \$58,539; funds provided in the FY2004-05 budget.

# REQUEST WAIVER OF SEALED BID PROCESS, PUBLIC SERVICES BUILDING GAS-FIRED BOILER VALUE OPERATOR REPLACEMENTS

Administration advised that the gas-fired boiler in the Public Works building requires repair and the quote received by W.T. Heaney Company, the company that has maintained the unit for a number of years, exceeds the \$4,000 limit in the Purchasing Ordinance, requiring sealed bids. Administration recommended that Council waive the bid process and authorize the work be completed by W.T. Heaney Company given that it would be

unlikely that another qualified contractor would be able to perform the work in an efficient and timely manner.

Responding to a question, Director Gushman stated that the value operators requiring repair are approximately 30 years old and have experienced problems over the last five years.

**RESOLUTION 11-04-267** Motion by Mitchell, seconded by Knol, to approve waiver of the sealed bid process for the replacement of the gas-fired boiler value operators in Public Services Building and authorize the work be completed by W.T. Heaney Company of Southfield in the amount of \$6,950.

### **PUBLIC COMMENT**

No public comment was heard.

### **COUNCIL COMMENT**

Councilmember McShane congratulated State Representative Vagnozzi, who was present, on his re-election to the House of Representatives.

McShane proposed meeting with the Downtown Development Authority (DDA) Board at their next meeting scheduled for Tuesday, December 7, 2004 at 8:00 a.m. Discussion followed regarding the pros and cons of meeting with Board at their regular time.

At Council's suggestion, City Manager Pastue stated he would follow-up with the DDA Board to set a meeting date and time.

Councilmember Bush noted that the wife of Mayor McDonald of Wixom passed away.

Knol noted that Farmington Hills recently updated its website and suggested that it might be economically beneficial to use their vendor to update the City's as well.

Mayor Campbell thanked State Representative Vagnozzi for attending the meeting.

Mayor Campbell noted a resolution passed by the Michigan Municipal Finance Officers Association recognizing the many contributions made by Clerk/Treasurer Cantrell to the Association and conferring on her an Honorary Life Membership. He further noted a letter received from Governor Granholm requesting Cantrell's participation in a special

committee, the Michigan Committee on Governmental Accounting and Auditing.

Cantrell stated that the recognitions attest to the commitment and support of the professional development of staff from Council and Administration.

Mayor Campbell noted a letter received from Tracy Thompson indicating that she does not wish to be reappointed to the Cable Access Commission.

#### **SCHOOL ELECTIONS**

Clerk/Treasurer Cantrell referred to a document provided to Council concerning the process for determining how school elections would be conducted. She recommended that Farmington conduct school elections as a service to the community even though it has an option to decline to do so. She stated that cost should be a major consideration in determining a school election date.

Knol expressed her support for the November date for school elections in light of the substantial costs to do otherwise. She further noted that an election for a library millage should be held in November as well. Mitchell also expressed support for a November school and library millage election date, noting that it would be fiscally responsible. McShane stated that the City can not afford a May election.
