#### **BOTSFORD HOSPITAL AS LEVEL II TRAUMA CENTER**

Paul LaCasse, D.O., President and CEO of Botsford Health Care, presented an informative presentation regarding trauma facts and statistics. He shared the crucial services available to the Farmington Community and surrounding areas as they relate to Botsford Hospital as a Level II trauma center.

McShane asked how the City can get the facts about Botsford's trauma services out to the community.

# CONSIDERATION TO RENEW FARMINGTON ROAD MAINTENANCE AGREEMENT WITH ROAD COMMISSION FOR OAKLAND COUNTY

Pastue stated the road commission made changes to agreement from prior years. Primary changes dealt with the obligation of the City to notify of defects within a specific time period. Review of the agreement revealed that this change somewhat reduces governmental immunity by creating more of a contractual obligation.

Schultz responded there is no objection to the agreement. There is nothing improper or illegal.

<u>RESOLUTION 03-10-048</u> MOTION by Knol, seconded by McShane, to renew an agreement with the Road Commission for Oakland County in the amount of \$20,319.52 for the maintenance of Farmington Road, between Eight Mile and Grand River, for a one-year period beginning October 1, 2009.

Responding to an additional question from McShane, Gushman stated the pool painting has been scheduled weather permitting. He advised they need one week to complete the 3-step process.

Knol asked about the signage for the loading zone in front of the Civic Theatre.

Pastue responded the issue has been addressed several times with the contractor and the City has considered going ahead and installing the signs. He advised once the signs are installed enforcement will take place initially issuing warnings relating to the intended purpose of the zone.

Gushman responded the contractor has assured him the signs will be installed in approximately one week.

McShane stated they have one week to put up the signs.

#### **PUBLIC COMMENT**

Dominic Castro, owner of Luigi's Restaurant, expressed concern regarding a citation he received recently due to an empty egg carton left on the ground next to his outside trash bin. He questioned why the City did not discuss the matter with him first before issuing the ticket. He would have been happy to remove the egg carton and assure the City he would be more diligent in keeping the area maintained.

Pastue advised there has been a concerted effort to ensure the areas around the dumpsters in the downtown are cleaned and maintained. He will discuss the matter further with Mr. Castro.

#### **COUNCIL COMMENT**

In referring to the public comment, Wright stated the importance of harmony and balance in the community.

Knol reminded residents to complete the Census form and encouraged them to contact their friends and family in Florida and Arizona regarding the importance of completing the form.

Pastue confirmed his office sent out a letter to all residents regarding the census.

Knol advised population is one factor the state and federal government use in grants, economic development, education, transportation, roads and public safety. All of those areas in some way tie into the funding from the state and

federal government. Knol acknowledged and congratulated Farmington Public Safety for solving the "Great Scott" homicide from 1979.

On behalf of Mayor Buck, Wiggins advised Mayor Buck witnessed the Public Safety Department in action during a recent fire at a business on Nine Mile Road. Mayor Buck recognized and thanked the Public Safety Department for their professionalism and efforts to protect the Farmington residents and their property.
