4. FARMINGTON ROAD STREETSCAPE - AUTHORIZE PAYMENT FOR ACQUISITION OF A TEMPORARY EASEMENT AND PERMANENT STORM SEWER EASEMENT FOR THE CVS PROPERTY

City Attorney Saarela gave a project update with current information and status. Discussion included easement value; attorneys' fees incurred by CVS, Affinity RE, LLC and the lender for review and revision of the easements; costs related to the owner's property management company's work on the easement; costs related to amending the lease between Affinity RE, LLC and CVS to identify the driveway closure; and costs to relocate the existing CVS sign to the south driveway entrance.

Move to authorize payment of \$60,467.00 to Affinity RE, LLC for acquisition of a Temporary Easement and Permanent Storm Sewer Easement for the CVS Property, subject to minor modifications that might be necessary by City Attorney pending feedback from the lender.
