We have received a new application for the Façade Improvement Program for the Village Mall. The Design Committee will conduct its review of the project for appropriateness at its January meeting. Final reports are forthcoming for the 2009 Farmers Market, the Harvest Moon Dance, Holly Days and the Streetscape Promotion Campaign. Nominations are due for the Mary Martin Service Award by Friday, January 15, 2010. The appreciation reception is planned for Tuesday, March 9<sup>th</sup>. The City is organizing an ad hoc committee to review and evaluate the operations of the Farmington Civic Theatre. A representative from the DDA is requested. Please relay your interest to the City Manager. Main Street Oakland County will conduct an annual review of our program on January 21<sup>st</sup>. A board meeting typically is part of the day's activities. Lastly, the board expressed interest in meeting with the Planning Commission, or a subset thereof, to discuss downtown development.
