5. PUBLIC COMMENT

Cheryl Blau, 23350 Cass Avenue, presented a gift to Councilmember Taylor as a thank you for her service to the Farmington Area Arts Commission.

6. PRESENTATIONS AND PUBLIC HEARINGS

A. Introduction of Chamber of Commerce Director Susan Arlin

Bowman introduced recently appointed Director of the Greater Farmington Chamber of Commerce, Susan Arlin. After talking about her vision for the Chamber and its role in the future, Arlin lined out specific goals for the GFCC in Farmington. Council comments were supportive and appreciative of Arlin's accomplishments and skills.

B. Pathways Committee Presentation

City Council established the Pathways Committee in November 2020. The Committee has met monthly since their first meeting in February 2021 and worked on a variety of projects. Director Weber introduced Tim Prince, member of the Pathways Committee, to give an overview report of their first-year goals, accomplishments, and recent findings of the committee.

LaRussa commended the committee for their work in only a year. He noted the passion and commitment apparent from this committee and encouraged the group to continue to work together with other groups interested in the same goals. Schneemann echoed LaRussa and asked about specific areas of the city. He requested that the committee look at the underpass where Farmington Road goes under M5. Balk thanked Prince and said she appreciated the walkability of the city. Taylor thanked her fellow members on the Pathways Committee and described further activities of the group. Bowman said she was appreciative of all the connections they have made with other groups, reaching out to the DPW, having a good working relationship with the City, and finding solutions to issues that affect the community daily.

C. OHM Warner Mansion Study Results

City Manager Murphy introduced Chris Riggert of OHM to present an overview of a study of potential uses for the Governor Warner Mansion. A copy of the presentation was available online after the meeting, and public input will be sought before discussions and decisions are made. Highlights included Community Engagement activities that were used, an Existing Conditions Inventory for the property, and seven main potential improvement approaches.

LaRussa thanked Riggert and OHM for their professionalism and thoroughness in doing this study. He also commended the community for contributing much of the feedback necessary for the report. Taylor asked about whether residents can provide feedback on the report itself, and Riggert indicated that a format will be provided and included with the study document on the City website.

7. NEW BUSINESS

A. Special Event: Farmington Community Library, Family Fun in Riley Park & Pavilion Story Time

Murphy requested approval of annual events as hosted by the Farmington Community Library

Move to approve Farmington Community Library Special Event Application for: Pavilion Story Time, Thursdays on June 16, 23 and 30; and July 7, 14 (possibly Founders week), 21 & 28 from 11 a.m. until noon; and Family Fun in Riley Park, Wednesday evenings on June 22, July 6, 20, August 3 and 17, 2022 with set-up time starting at 6 p.m. and the actual concert from 7 until 8 p.m., provided that all pandemic-related guidelines are followed.**

Executive Director Knight requested that Council adopt a resolution approving the 2022 community events calendar, temporary liquor license applications, and street closures as planned for this year. She also requested permission for businesses within the DDA district to hold Sidewalk Shopping on any event day during 2022.

Weber explained an opportunity to apply for a grant to cover 50% of the cost of replacing the wooden fencing at the Shiawassee Park playscape.

In response to a question from Schneemann, Superintendent Eudy confirmed previous thoughts about the levels and grade of the proposed fencing. Discussion ensued about the replacement and disposition of the wooden memorial slats that presently make up the fencing.

E. Adopt Notice of Intent and Reimbursement Resolution for 2022 Capital Improvement Bonds to finance the Farmington Road Streetscape

Murphy recommended the adoption of a resolution that provides notice of intent to issue Capital Improvement Bonds to fund the Farmington Road Streetscape. The resolution instructs the City Clerk to publish a notice, notifying electors of the City's intent to issue bonds and their referendum rights which run from the publication of the notice for 45 days. The 45-day period would conclude in early March 2022. The bonds are intended to be repaid 50% from the City's Capital Improvement Millage Fund and 50% from DDA Capture.
