McShane stated how much she liked the format and content of a recent City Newsletter.

Discussion followed regarding the increasing costs of water and sewer.

Galvin commented on recent misinformation posted on facebook regarding redevelopment in the downtown.

Galvin clarified that Council has not authorized anything in a closed session regarding a purchase agreement or appropriation of funds. Council has the right in closed session to deliberate regarding land acquisition and employee matters. He advised Council will enter open session if a vote needs to be taken as a result of closed session deliberation.

Galvin stated the City Attorney, City Manager and City Clerk do a wonderful job of assisting Council in navigating the provisions of the Open Meeting Act and ensuring Council remains compliant.

Galvin expressed concern that one of the members of the Historical Commission has made some serious claims against Council. He pointed out that once a message is posted on social media it is permanent and accessible to everyone.

Schneemann discussed his recent attendance at a Call to Action meeting. He shared statistics regarding the increase use of marijuana. He stated it has now overtaken alcohol

for people driving under the influence. He stated the use of heroin is up 280% in the last ten years. It was reported in Farmington Hills that there have been 12 deaths thus far in 2015 as a result of heroin overdose. He stated it is an epidemic and Farmington is not immune. He will meet with Director Demers to determine if steps can be taken by Council to address this issue.
