

2012 proved to be no different than the past few years with many challenges faced by the public safety department. Through it all, public safety staff continued to provide the highest level of professional service to the citizens of Farmington.

We are pleased to announce for the fifth straight year that "Part A" crimes (most serious) decreased in 2012 by 13.1% and for the first time fell below four hundred incidents. As part of that, commercial break-ins were down 53.8% (13 vs. 6 in 2012), robberies were down 400% (4 vs. 0 in 2012), malicious destruction of property was down 12.2% (41 vs. 36 in 2012) and there were seven (7) residential break-ins in 2012, which was the same as 2011. Unfortunately, there was a 95.8% increase in the number of larcenies from autos (47 vs. 24 in 2011) with twenty-eight (28) of those incidents occurring on two (2) different days. I am proud to report that a suspect was quickly identified, arrested and charged in each of those crime sprees.

The public safety department responded to over 700 calls for service involving a sick or injured person and an additional 137 calls for service involving a fire related incident such as down wires, odor investigations and structure fires. In 2012 the department extinguished two (2) structure fires with an estimated property damage of just under \$140,000.00. There were no fire related injuries or deaths in 2012.

The biggest challenge faced by the public safety department in 2012 was the closing of dispatch and the establishment of a public safety cadet program. Following countless hours of planning and training, October 1, 2012 the Farmington Public Safety Department ceased operation as a Public Safety Answering Point (PSAP), otherwise known as dispatch. The records department underwent a major change by moving its office space to the former dispatch room and a records person being assigned to work afternoons. The department hired four (4) new cadets to staff the front desk and monitor prisoners when records staff were not working. This was a very difficult transition for the department and staff to work through.

It should be noted that crime data figures contained in this report may contain slight number variations. This is due to the ongoing reclassifications of incidents determined to be civil, items reported stolen that were misplaced, lost property determined to be stolen, etc.

On behalf of the proud members of the Farmington Safety Department, we again thank the city officials for your support. I am pleased to present the 2012 Annual Report.










# Farmington Public Safety Organizational Chart














# DEPARTMENT ACCOMPLISHMENTS (2012)

- There were no fire or crime related deaths.
- No public safety personnel were seriously injured or killed in police or fire activities.
- Serious "Group A" crime decreased 11.3% in 2012. This decrease follows a 4.2% drop in 2011 "Group A" crime.
- Ninety-nine (99) fewer "Group A" crimes occurred in 2012, compared to 2008. This is a twenty percent (-20%) reduction in five (5) years.
- Total number of burglaries decreased by six (6) in 2012 (21) as compared to 2011 (27).
- There were no reported robberies in 2012, down from four (4) in 2011.
- Five (5) year comparison of "Part B" crimes dropped twenty-five percent (-25%) in 2012 (406) from 2008 totals (543).
- Traffic crashes dropped for the fifth straight year by twenty percent (-20%); 260 accidents in 2012 vs. 326 accidents in 2008.
- The public safety department continued Apartment Watch patrols conducted by vehicle, bicycle and foot patrols.
- The public safety department began a Motor Carrier program. An officer received extensive training and has been aggressive in motor carrier traffic enforcement. Farmington streets are safer as a result of this assertive enforcement.











#### **COMMUNITY POLICING**

The Farmington Public Safety Department embraces community partnerships that promote effective police and fire services. Sixty-eight (68) special services and programs focus on youth, neighborhoods, roadways and the businesses in our community. New or revised programs in 2012 are noted in bold print.

#### **ALCOHOL TESTING**

In cooperation with the probation department at the 47<sup>th</sup> District Court, the public safety department is testing probationers for the use of alcohol each morning.

#### **ANIMAL TRAPPING PROGRAM**

The department loans animal traps to residents (returnable deposit fee).

#### APARTMENT WATCH PROGRAM

The public safety department received a COPS Hiring Recovery Program (CHRP) grant to replace a vacant public safety officer position. The department has increased police patrols, bike patrols and foot patrols in the city's thirty-four multi-housing communities. Monthly crime prevention presentations are part of the program.

#### **AUTO IMPOUND**

Public safety officers electronically complete impound paperwork when impounding vehicles, which automatically sends the necessary information to the tow companies.

#### **BICYCLE SAFETY EVENTS**

The Farmington Public Safety Department, along with LOC Federal Credit Union and AAA, sponsors bicycle safety events. The department also sells bicycle licenses to help identify lost or stolen bicycles.

#### **BLOCK PARTIES**

Department personnel visit neighborhood block parties with police cars and fire trucks, and distribute crime and fire prevention materials.

#### **BUSINESS WATCH**

Special meetings, programs and crime alerts are coordinated with the members of our business community.

#### CHILD CAR SEAT SAFETY INSPECTION

Citizens can have their child's car seat inspected for safety, proper installation and compliance with State law by the department's fire marshal who is a graduate of the National Child Safety Certification program. The department also has a limited number of free car seats to distribute.

#### CITIZEN AWARD RECOGNITION PROGRAM

The department recognizes members of the community who assist the public safety department.

#### CIVIC ORGANIZATIONS

Members of the department participate in thirty-eight (38) community and professional organizations.

#### CLICK IT OR TICKET

In addition to regular seat belt enforcement, the department participates in annual Memorial Day selective enforcement initiatives. Such initiatives save lives, reduce injuries, and help keep Michigan ninety-four percent (94%) compliant.

#### **COMMUNITY COALITION WORKSHOPS**

Members of the department participate in substance abuse and relationship violence workshops and programs.

#### COMMISSION ON CHILDREN, YOUTH & FAMILY

The department participates in the community commission and their events that promote the children, youth and families of our community.

#### COMPLIANCE CHECKS

The department conducts several annual alcohol and tobacco operations to discourage sales to minors.

#### **CRIME ALERTS**

The department expanded the capabilities of the department's crime alert notification system by utilizing Nixle software. Residents can now choose to receive text messages or Twitter communications. The public safety department can now send photographs and area messages with the alerts.

#### CRIME PREVENTION NOTICE PROGRAM

Public safety officers issue crime prevention notices and warnings to residents. Examples include warnings issued to residents who leave valuables unattended, doors unlocked or garage doors open.

#### CRIME WATCH WEBSITE

Farmingtonpublicsafety.com is the web address. The site features crime statistics, Neighborhood Watch information, annual reports and other items of interest.

#### **CROP WALK**

The department coordinates participation and the safety of three hundred annual walkers who raise money for the needy.

#### CROSSING GUARD PROGRAM

The department hires, manages and conducts annual training for school crossing guards at designated schools.

#### **DECOY CARS**

The department strategically places unoccupied patrol vehicles on streets to deter speeding and in business areas to discourage crime.

#### DTE STREET LIGHT DETAIL

In cooperation with Detroit Edison (DTE), public safety officers check all the street lights in the city each month and report any outages to DTE for repair.

#### E-CRASH

Public safety officers electronically complete accident reports. Motorists and insurance companies can still obtain copies of the reports electronically.

#### **FACEBOOK**

"Like" us on Facebook to get the latest Farmington Public Safety Department information and updates.

#### FARMINGTON YOUTH ASSISTANCE

Department members attend board meetings and make appropriate referrals as an alternative to criminal prosecution.

#### FIRE INSPECTION PROGRAM

The department is proactive in conducting fire inspections to reduce loss of life and property.

#### FIRE SAFETY/PUBLIC EDUCATION PROGRAMS

The department conducts various fire safety education programs to pre-schools and other community groups.

#### FIRST AID, EMERGENCY PROGRAM

The department participates in several educational programs such as the Emergency Preparedness Commission.

#### FOOT BEAT PATROLS

Public safety officers are assigned to foot patrols in the downtown center and at special events.

#### FRAUD-NET

Detectives fight fraud and bank crimes with an on-line database linking bankers and law enforcement officers. The partnership promotes crime prevention and helps solve crimes.

#### **GUN LOCK GIVEAWAY PROGRAM**

The department gives away free locks to residents to promote gun safety.

#### HALLOWEEN FESTIVAL, CANDY PATROL

The department participates in the safety coordination at special Halloween events. Special patrols target neighborhoods and officers give away Halloween treats.

#### HAZARDOUS MATERIALS TEAM

Fire Marshal Madeline represents Farmington on the North Oakland County Hazardous Materials Response Team.

#### HOLIDAY ALCOHOL ENFORCEMENT PROGRAM

This award winning program utilizes public education, compliance operations, special patrols and partnering with several community organizations and the business community.

#### HOUSE CHECK PROGRAM

Residents may notify the department when their homes may be vacant for a period of time. The information is kept in dispatch and is helpful when the need arises to contact the homeowner should a crime or emergency occur.

#### INTERNSHIP TRAINING

College students or individuals interested in public safety who reside or work in Farmington may apply for internship training and education.

#### JAIL DIVERSION PROGRAM

Public safety personnel are trained to divert mentally ill prisoners into treatment facilities as an alternative to jail.

#### KNOX BOX PROGRAM

The department coordinates the installation of security boxes for elderly or handicap residents. The boxes contain keys to allow public safety personnel easy emergency access.

#### LOST AND FOUND ANIMALS

The department logs lost animal information to help locate owners when animals are found.

#### MICHIGAN COMMUNITY CHILD WATCH

This program operates in conjunction with Farmington Public Schools. Community members are screened and homes are identified where children may seek safe haven.

#### MiHAN

The department partnered with the Michigan Health Alert Network to electronically receive critical emergency public health information. Public safety officers utilize the information to properly respond to public health emergencies.

#### MISSING CHILDREN PROGRAMS

The department participates in child identification efforts. Policies and procedures are in place for quick activation of "Amber Alert" and "A Child Is Missing" programs. One thousand residents a minute can be notified by telephone to watch for a child.

#### MOUNTAIN BIKE PROGRAM

The department has three mountain bikes used by officers at special events and during specific tactical operations.

#### MULTICULTURAL, MULTIRACIAL COMMUNITY COUNCIL

The department is represented on the steering committee and participates in the philosophies and programs of this important group.

#### NARCOTICS SUPPRESSION UNIT (NSU)

Specially selected officers investigate illegal drug tips, execute search warrants and arrest drug offenders.

#### **NEIGHBORHOOD WATCH**

The department conducts monthly meetings with residents to teach crime prevention and provide crime updates. Special crime alert bulletins are delivered by community policing officers to neighborhoods experiencing crime.

#### **OPERATION SAFE RIDE**

The department partners this project with Mothers Against Drunk Driving to coordinate safe rides home for individuals consuming excess alcohol on New Year's Eve.

#### PARADE COORDINATION

The department participates and ensures community safety at the Little League Parade, Homecoming Parade, Memorial Day Parade and Founder's Festival Parade.

#### PARENT FORUMS

The department partners with Farmington Public Schools to present annual crime prevention programs at parent educational forums.

#### POLICE BENEVOLENT ASSOCIATION

The Farmington Public Safety Department, Farmington Hills police and fire departments and the Franklin Police Department hosts an annual golf outing, dinner and raffle, as well as live and silent auctions. The event raises funds to assist public safety personnel, their families and members of the general public during times of death, illness or personal crisis.

#### PRIVATE PROPERTY ACCIDENT PROGRAM

The department responds to private property vehicle crashes, preserves the peace and records the facts on a police report.

#### PUBLIC SAFETY TOURS AND PRESENTATIONS

The department provides tours of the public safety building, vehicles, and responds to public safety requests for speakers and presentations.

#### RECRUITMENT PROGRAM

The department actively recruits officer candidates at universities, colleges and academies. Applications are released throughout the year.

#### RESERVE OFFICER PROGRAM

The department recruits, screens and trains members of the community who supplement police, fire and civil defense protection.

#### SCHOOL LIAISON OFFICER PROGRAM

This successful program has serviced all Farmington public schools since 1990. Officer

Christine Schutz is assigned to Farmington High School. She provides on site support to school administration, provides classroom instruction, serves as a connection with students, provides special presentations to parent groups, serves on various school committees, conducts crime prevention and enforcement, and investigates criminal matters occurring at the school.

#### SCHOOL SAFETY PROGRAM

The department is prepared to respond to all types of school and community emergencies. The Farmington School District Director of Safe Schools and department personnel meet regularly and discuss concerns and safety issues. The public safety department maintains a special vehicle equipped with emergency equipment should a serious incident require a rapid response.

#### SELECTIVE ENFORCEMENT PROGRAM

Patrol officers conduct weekly selective traffic enforcement details at various locations throughout the city, several at the request of residents and Traffic and Safety Board members.

#### SERVICE COMPLIANCE PROGRAM

The department promotes professional traffic stops and maintains a formal complaint procedure. The department also utilizes in-car cameras to verify professional conduct and re-create a factual record of public contacts.

#### SMOKE ALARM GIVEAWAY PROGRAM

The department provides free, battery operated smoke detectors to residents of the community.

#### SOBRIETY COURT HOME VISIT PROGRAM

Commander DuLong, Sergeant Friess, PSO Schutz, PSO Morche and PSO Wash visit the homes of residents arrested for drunken driving to encourage sobriety.

#### SPECIAL EVENT COORDINATION

The department plans and coordinates public safety personnel for special community events. Special operational orders are written defining department procedures.

#### SPECIAL PATROL PROGRAMS

The department identifies areas for special tactical patrols of uniformed or plain clothes officers. The department also honors requests for special attention patrols from residents and business owners.

#### SPEED TRAILER PROGRAM

The department identifies areas requiring "speed awareness" and "deterrence." A strategically placed trailer informs passing motorists of their speed. The department honors reasonable suggestions for trailer placement from residents and business owners.

#### **START**

The department participates in the Safe Therapeutic Assault Response Team. Investigators are partnered with specially trained forensic nurses to collect sexual assault evidence and counsel sexual assault victims.

#### TEDDY BEAR GIVEAWAY PROGRAM

The department stocks donated teddy bears to give to children who are involved in traumatic events.

#### TRAFFIC AND SAFETY BOARD

The department acts as a liaison with the city's traffic board and traffic engineer. Public safety officers encourage citizens with unsolved traffic concerns to contact the Traffic and Safety Board.

#### TURN AROUND PROGRAM

Students at Farmington schools who turn their lives around in a positive manner are honored at an annual banquet. The department is a major sponsor and members serve on the planning and nominations committees.

#### VEHICLE LOCK OUT PROGRAM

Public safety officers respond to assist citizens locked out of their vehicles.

#### WASTE WATCH

The department partnered with community Waste Management workers who are trained to act as extra eyes and ears to report crime.

#### WEATHER EDUCATION PROGRAM

The fire marshal coordinates weather and tornado alert publications for free distribution to the public. The department also promotes public education and notification during tornados and severe weather alert month.









#### **TECHNOLOGY ENHANCEMENTS**

The Farmington Public Safety Department added one (1) new technology in 2012, one (1) technology in 2011, six (6) technologies in 2010, six (6) in 2009, five (5) in 2008, nine (9) in 2007, seven (7) in 2006 and fifteen (15) in 2005. Fifty (50) new technologies have been introduced in the past eight (8) years to enhance public services.

The Department of Public Safety added the following technology in 2012:

• Closed Circuit Monitoring. The public safety department obtained a grant to place cameras at Shiawassee Park Playscape and Heeney-Sundquist Pavilion.

Nine public safety officers are assigned to the patrol division: Richard Hennessy, Scott Herrmann, Aaron

Malewski, Alan Baranski, Mark Keeley, Patrick Spelman, Shane Wash, William Wood and James Wren.

In October of 2012 this department ended its long standing dispatch center and transferred dispatch responsibilities to the city of Farmington Hills. Four cadets were hired in 2012 and tasked with the responsibility of monitoring the front desk, monitoring the Jail, and assisting officers with their everyday responsibilities so that the Farmington Public Safety Department can remain open twenty-four



hours a day, seven days a week. These cadets are Alicia Trotter, Christy Cooney, Matthew Council and Paul Hughesdon. They are assisted by two fire reserves who are cross trained to handle cadet responsibilities when the cadets are not working. The cross trained fire reserves are Sean Skinner and John Dresden.

The patrol division prides itself in its fast response to police, fire and medical emergencies. Aggressive subdivision patrols and the fast response times allow officers to make arrests and prevent crime proactively. The "Apartment Watch" program encourages officers to aggressively patrol apartment complexes resulting in arrests and crimes being prevented. Patrol officers also aggressively enforce motor carrier laws as well as "drunk driving" laws which makes for much safer roadways throughout the city.



The patrol division provides numerous community policing services. For example, our officers patrol neighborhoods and issue crime prevention notices (blue cards) indicating potential criminal opportunities, hazards or concerns observed at a residence. Station tours, visiting block parties, picking up stray pets, assisting residents who have fallen, home/vehicle lockouts, selective enforcement on neighborhood streets and any other requests for assistance from

citizens are just some of the services that the patrol division provides and residents enjoy. The officers of the patrol division take great pride in providing this extra

personalized service to our residents.

#### SPECIAL OPERATIONS

The Officer-in-Charge of the Special Operations Unit is Commander Frank Demers. The commander supervises Detective Andrew Morche, Detective Scott Brown, and School Liaison Officer Christine Schutz. The Fire Marshal, Sergeant Reginald Madeline, is also assigned to the Special Operations Unit.

Special Operations personnel are responsible for some of the following functions; criminal investigations, evidence technician services, photography, fire inspections, fire equipment maintenance, reserve public safety officer and reserve fire fighter background investigations, Neighborhood Watch, evidence and property room management, school liaison program, solicitor permits, alcohol, tobacco and massage compliance operations.

In 2012, Special Operations personnel received specialized training on the topics of National Incident Management System ICS 300 & 400 training, Homicide Investigation, Arson Cause & Origin Investigation, Cyber-Crimes Investigations, Evidence Technician Certification, Firefighter Safety & Survival Training, Scott Air Pack Maintenance Training, Advanced Sexual Assault Investigations and Juvenile Justice Training.

#### Narcotics Suppression Unit

The Farmington Public Safety Department's Narcotic Suppression Unit (NSU) has continued to strive to suppress the illegal drug use/supply in the City of Farmington and surrounding communities.

The successes of Farmington NSU have been the result of the collaborative efforts of concerned community members coming forward with drug related tips and information, along with the drug related arrests made by dedicated department personnel.

In 2012, Farmington NSU Officers investigated eighteen (18) narcotic tips, which led to several drug related targets and a nexus to illegal drug use/sale in the City of Farmington and surrounding community.

Farmington NSU strives to work with the community, along with regional drug task forces, to suppress narcotic activity and other crimes in the City of Farmington.

#### **FIRE SERVICE**

Fire Marshal Reginald Madeline oversees the department's fire and medical operations. As a part of his regular duties, the fire marshal conducts fire inspections, schedules and performs maintenance on the department's fire apparatus and coordinates monthly fire fighting and medical training. All sworn personnel are certified firefighters and medical first responders. Four members of the department have advanced medical training and are licensed emergency medical technicians. Additional services provided by the department's fire service include; fire extinguishment, hazardous materials response, smoke detector give away program, public education seminars on fire safety, first aid, infant/child safety seat inspections and the Commercial/Residential Knox Box program. Due to quick response times and quality training, the fire loss in the past year is estimated at \$137,500.00 in 2012.



#### RECORDS AND DISPATCH

Records/Communications Supervisor Corinne Brazzil supervises five dispatchers; John Foxton, Danielle Shorrock, Jennifer Jordan, Jo-Ann Alcantara, Sean Skinner and one part-time clerk Debra Comini.

On October 1, 2012, Farmington Public Safety ceased being a Public Safety Answering Point (PSAP). Farmington Hills dispatch assumed the responsibility of dispatching all emergent and non-emergent calls for the Farmington Public Safety Department.

Records personnel continue to process all requests for reports (police, fire, medical and accidents), including Freedom of Information requests. They are also responsible for the processing of court dockets and subpoenas, false alarm billing, bicycle licenses, parking permits, non-criminal fingerprints, police clearance letters, warrant processing/validations and requests for station tours.

#### **TRAINING**

The public safety department continues to seek out training opportunities for both sworn and civilian personnel to increase both knowledge and practical skills. The following pages are the training courses personnel attended during 2012.

#### POLICE TRAINING

- Police Staff and Command: Commander DuLong attended the Eastern Michigan University Police Staff and Command School graduating in October 2012. Staff and Command is a police management school focusing a variety of issues including staffing, budgeting, discipline, and media relations.
- Report Writing: A course designed to assist officers with writing good reports that include the elements of the crime.
- Sex Offender Registry Training: A free course sponsored by the State of Michigan that focuses on the laws and requirements for proper sex offender registry.
- **Identity Theft Investigation:** A free course sponsored by the Michigan Identity Theft Task Force that teaches investigators about the current themes in identity theft investigations.
- Child Passenger Seat Training Workshop: A free course sponsored by the State of Michigan Office of Highway Safety Planning that focused on the laws and proper installation of child car seats.
- Commercial Motor Vehicle Awareness: A free course sponsored by the Michigan State Police to give road patrol officers an understanding of commercial vehicle enforcement laws.
- The Bullet Proof Mind: Psychological Preparation for Combat: A one day class that examines what it takes to survive deadly force encounters. The instructor is a nationally known instructor with a military background.
- State of Michigan Fireworks Laws: A free, one day course sponsored by the State of Michigan that examined the new laws regarding fireworks in the State of Michigan.
- Commercial Motor Vehicle Inspection Training: A six day course, sponsored by Michigan Police Training that covers both general enforcement and inspection of commercial motor vehicles in Michigan.

- Cops in Court: A one day course, sponsored by the Michigan State Police that examines the court testimony process and officers.
- Undercover Survival / Lawful Invasions: A two day course that focused on techniques used by undercover officers and issues related search and seizure and the 6<sup>th</sup> amendment.
- Risk Management Seminar: A one day class instructed by a nationally known expect in municipal risk management. The class focused on minimizing risks for police agencies.
- Death Notification Seminar: A one day class that prepares officers to perform death notifications in a professional and sincere manner.
- Synthetic Drug Training: A one day class that focuses on current synthetic drug use and the laws that regulate them.
- Law Enforcement Officers Killed and Assaulted: A one day class sponsored by the Michigan State Police that is designed to raise officer awareness of "The Deadly Mix" and how attitudes, behaviors, and circumstances impact officer safety.
- Taser Instructor Recertification: A two day class (one classroom / one on-line)
  that recertifies the department's taser instructors to allow them to instruct other
  department members in the use of a taser.
- Homicide and Crime Scene Management Training: A three day course sponsored by the Livonia Police Department designed for detectives. The class focuses on the management of homicide scenes.

#### FIRE TRAINING

- SCOTT Airpack Maintenance Certification Training: A one day class that certifies the attendee to service our current airpacks when needed.
- Firefighter Rehabilitation and Medical Monitoring Training: A course that provides for the knowledge to set up and administer firefighter rehabilitation according to current fire standards.
- Fire Cause and Origin Training: A two day course that concentrates on fire cause and origin investigations.
- Live Burn Seminar: A one day course that involves an actual burn of a small structure and then a mock arson investigation.

- Live Burn Train the Trainer Course: A one day course that allows for the attendee to manage live burn trainings for other department members in the future.
- Consumers Energy Joint Tabletop Exercise: A one day exercise, sponsored by Oakland County Homeland Security worked through a scenario involving a natural gas emergency.
- Live Burn Training: All department members completed live burn training at a burn building located at the Wixom Fire Department.

In addition to the above training, below is a list of training that was conducted at the City of Farmington throughout the year of 2012:

- Airway, Splinting, and Spinal Immobilization (Medical)
- Cold Weather Emergencies (Medical)
- Trauma Assessment (Medical)
- National Incident Management Training (Fire)
- Search and Rescue Training (Fire)
- Thermal Imaging Camera Training (Fire)
- Annual Fire Truck Drivers Training (Fire)
- HAZMAT Refresher Training (Fire)
- Rope and Hose Rescue / Firefighter Rescue Training (Fire)
- CPR and AED Training (Medical)

In March of 2012, the department was able to utilize the old K-Mart building to train in building searches, simunitions, and defensive tactics. Each department member was put through several tactical scenarios that required them to make quick decisions regarding manpower, communications, leadership, and the force continuum.











#### 2012 GRANTS AND PARTNERSHIPS

The public safety department seeks annual supplemental funding sources through grants and partnerships to enhance services and reduce taxpayer expenses. section of the Annual Report summarizes some of the grants utilized or received in 2012.

#### EDWARD BYRNE JUSTICE ASSISTANCE GRANT (BYRNE-JAG)

In order to address instances of vandalism to the Sundquist Pavilion and the Shiawassee Park playscape area, the Farmington Public Safety Department applied for and was awarded the Edward Byrne Justice Assistance Grant (BYRNE-JAG) to install surveillance cameras in these areas. Included in this grant is funding to install an additional Pan/Tilt/Zoom (PTZ) camera that will be affixed to a pole at Grand River Avenue and Grove Street (north side of intersection) and monitored by public safety personnel in the station. This camera will be useful in monitoring crowds during downtown events to identify potential problems and to allocate public safety resources The total amount of the grant was \$25,742.00 and was fully more efficiently. implemented in 2012.

#### DEPARTMENT OF JUSTICE BULLETPROOF VEST GRANT

The public safety department applied for and was awarded a grant to assist with the purchase of bulletproof vest for individual officers. Six (6) officers were able to purchase bulletproof vest with 50% of the cost being covered by the grant. The grant was just under \$2,000.00



#### **2012 MAJOR INCIDENTS**

The following incidents are a synopsis of major incidents receiving community wide attention in 2012.

#### FEBRUARY 27, 2012-ASSAULT WITH KNIFE

A mentally distraught husband attacked his wife with a knife. The wife was able to fend off the attack and called for assistance from her son, who was in the next room. The husband then began to struggle with the son who was able to disarm his father and secure him until public safety officers arrived. Officers learned that the husband had been struggling with untreated depression for quite some time. The husband was arrested and charged with felonious assault.

#### **MAY 24, 2012-IDENTITY THEFT**

A City of Farmington resident reported that unknown person(s) opened numerous credit card accounts using her personal information with various stores. The suspects charged in excess of \$10,000 in unauthorized purchases. Video surveillance was obtained from one of the stores that identified three possible suspects. After months of investigation utilizing social media and other investigative techniques, investigators were able to identify the suspects who were part of an organized identity theft ring. The case was turned over to the U.S. Department of Homeland Security who charged two suspects with Identity Theft. Additional charges are pending against a number of codefendants.

#### JUNE 2, 2012-HOME INVASION/ARMED ROBBERY

A Baltimore, MD, man was visiting his sister in her Farmington home. At approximately 1:30 a.m., while alone in the home, the man was awoken by two suspects who broke into the home and demanded his wallet and cell phone. One of the suspects brandished a pistol and struck the man on the side of his head causing injury. The man gave the suspects his cell phone and wallet at which time they left the home in an unknown direction. To date, investigators have been unable to develop any suspect information in this case.

#### JUNE 20, 2012-MULTIPLE LARCENIES FROM VEHICLES

Public safety officers responded to numerous reports of larcenies from vehicles on Violet Street. While processing one of the attacked vehicles for evidence, investigators noticed a mirror with apparent latent fingerprints. The prints were lifted and submitted to the Oakland County Sheriff's Office Crime Lab for analysis. Using the Automatic Fingerprint Identification System (AFIS) a suspect with a history of larceny arrests was identified. The suspect was subsequently located and arrested and charged with larceny from a vehicle.

#### JULY 17, 2012-LARCENY FROM BUILDING

A teenage resident on Robinwood Street had a large party at his house while his parents were out of town. Present at the party were numerous individuals both known and unknown to the resident. The following day, when his parents returned, it was discovered that numerous pieces of expensive jewelry and prescription medications were missing from the home. The resident informed his parents of the party the night before at which time a police report was filed. Following interviews with numerous individuals, investigators identified two (2) juveniles and one (1) adult responsible who confessed to their involvement in the theft. The individuals were subsequently charged with larceny in a building.

#### **AUGUST 15, 2012-MULTIPLE LARCENIES FROM AUTOMOBILES**

Public Safety officers responded to the Chatham Hills Subdivision for numerous reports of larcenies from vehicles. In total, eighteen (18) cars were attacked during the overnight hours. A latent fingerprint was obtained from one of the attacked vehicles. The print was submitted to the crime lab for AFIS analysis which identified a suspect with a history of larceny offenses. Investigators learned that the suspect pawned the items that were stolen at a pawn shop in Southgate, MI. The suspect was subsequently arrested and charged with larceny from auto. The items were recovered from the pawn shop and returned to the owners.

#### **REOPENED 1980 HOMICIDE INVESTIGATION**

In March, 2012, Farmington Public Safety investigators reopened the investigation into the death of Deborah Rentschler, whose body was found frozen in a parking lot in the area of Grand River Avenue and Drake Road on December 24, 1980. It was determined that Ms. Rentschler died as a result of manual strangulation. Many leads were pursued during the initial investigation, however, no suspect information was developed and the case went cold. Since reopening the case, investigators have teamed up with other cold case homicide investigators and reached out to the media with the hopes of developing new leads in the case. The investigation continues.
