#### Agenda Topic

Consideration to authorize final cost increase of replacement Freightliner truck chassis for DPW per revised pricing.

#### **Proposed Motion**

Move to authorize payment for the 2024 Freightliner 108 SD from Wolverine Freightliner Incorporated. The final pricing is \$102,303, an increase of \$4,253 from the September 2022 update.

#### **Background**

2023 Fiscal Year budget has funds allocated for the replacement of DPW dump truck/salt truck. Due to limited production capabilities of the heavy-duty truck market, there is a 12-month delivery schedule, and a 6-8 month outfitting schedule. Public Works Administration and Mechanic will evaluate the 1998 and 2000 model year GMC dump trucks to see which truck should be replaced first. DPW dump/salt trucks are on a 16-year replacement schedule. This replacement schedule has been extended due to the economic climate from 2007-2014. Purchase of the Freightliner chassis is separate from the outfitting of the chassis.

In February, 2022, Public Works Administration recommended accepting the speculative pricing information from Wolverine Freightliner-Eastside Incorporated in the amount of \$96,424 located in Mt. Clemens MI which reflects the Rochester Hills Co-op RFP-RH-20-023 agreement in February 2022. Public Works updated City Council of cost increase at the September 2022 of \$3,425 increasing the price to \$98,050.

Wolverine Freightliner has provided a final update confirming the pricing. The final pricing for the 2024 model has increased an additional \$4,253 from the September update to a total \$102,303.

#### **Agenda Topic:**

Revised Dinan Park Water Main Connection/Extension

#### **Proposed Motion:**

Move to approve revised agreement with Warren Contractors to install the water main extension in Dinan Park/West Parking lot in the amount of \$108,000.

#### Background:

Last week Public Works Water & Sewer Department began investigating the location of the 4" water main in the west parking lot. We discovered the water main does not extend as far to the east as records indicate. City Manager advised to update City Council of the findings.

Warren Contracting has provided a revised proposal to remove asphalt parking lot within the trench line and Dinan park area, install up to 175 lineal feet of 8" diameter water main from the Farmington Road gate well in Dinan Park to the dead end 4" diameter water main from Grand River, place 8" 21aa crushed aggregate base material, and resurface disturbed areas of asphalt. The previous proposal from Warren Contracting did not include asphalt restoration as nearly all the water main was within the footprint of Dinan Park. The revised quote includes replacement of asphalt in the west parking lot. A second phase of asphalt replacement will be conducted as the park is established.

Originally City Administration budgeted \$100,000 for this project in the 22/23 FY. The amended budget retained \$3,000 in the 22/23 FY budget and placed \$68,000 in the 23/24 FY budget due to the competitive quotes received. Ultimately this project will require a budget amendment allocating an additional \$105,000 of fund to this Fiscal Year's budget. A budget amendment will be submitted to Council when the project is completed. The Finance Director will provide all necessary documents for the amendments and reducing FY 23/24 budget accordingly.

Engineers at Orchard Hiltz & McClement (OHM) recommend awarding the revised Dinan Park/West Parking Lot Water Main extension to Warren Contracting located at 14979 Technology Drive, Shelby Twp, MI 48315 in the amount of \$98,700 with approximately 10% contingency of \$9,300 totaling \$108,000. Warren contracting will be the prime contractor on the Dinan Park project for the DDA and OHM will be providing the water main inspection services during the installation at no cost.

#### Regarding: Revised Recommendation of Award - Dinan Park Water Main Connection/Extension

On April 17, 2023, the City Council approved the quote from Warren Contractors & Development for performing water main construction through the area of the proposed Dinan Park between Sipp and Wina's on the west side of Farmington just south of Grand River. Following this, the City conducted further investigations and preparation work for the project in order to best prepare the contractor for completing the work in an efficient manner. While performing this work, the City determined that the existing dead-end water main, to the west, was not located where initial signs had pointed it to be. It was ultimately located at a distance 75-feet further away which meant that the connection point was further away than originally thought to be. With this new knowledge, Warren has provided a revised quote reflecting the additional water main quantity necessary to complete the tie-in construction as seen in the table below.

Contractor Name	Bid Amount
Warren Contractors & Development	\$98,700

The project scope consists of approximately 175-feet of water main to be constructed here in order to connect two (2) existing dead-end stubs.

Warren Contractors & Development, located at 14979 Technology Dr in Shelby Twp, MI, is the recommended bidder. Warren has been diligently completing the adjacent Farmington Road Streetscape project and has even helped the City out in already completing some work for the construction of the future pocket park. Additionally, OHM Advisors has had favorable past-experience working with this contractor on previous projects. We've spoken with Warren Contractors directly regarding the scope of work and anticipated project schedule, and they indicated that they are comfortable with completing all work items within the time allotted to substantially complete the project.

Based on the above evaluation, we recommend award of the Dinan Park Water Main Connection/Extension project to Warren Contractors & Development in the not to exceed amount of \$108,000.00, which includes an approximate contingency budget just under 10% to help cover unforeseen issues.

We look forward to continuing to provide our professional services on this project through the construction phase of work. If you have any questions, please do not hesitate to reach out.





#### Background:

At the April 17 Special City Council Meeting, council interviewed three candidates for the vacancy on the Board of Review:

- Charles Bridges
- Dr. Harrison Igwe
- Thomas Killeen

The term is through Dec. 31, 2024 – this is a partial term due to a board resignation.

The Board of Review is established pursuant to the General Property Tax Act of Michigan. The primary function of the Board of Review is to review the assessment roll prepared by the assessor, to hear appeals from property owners regarding their assessments, to consider poverty exemptions, and to make corrections regarding names and homestead exemptions. The City of Farmington contracts with the Oakland County Equalization Department for Assessor Services.

The Board of Review schedules a number of meetings each March to hear appeals regarding the assessment roll prepared by the Assessor. In addition, they hold a meeting in June and December to make technical corrections to the assessment roll.

- Meets each March to hear appeals for two or more days, as needed. Brief meetings scheduled for July and December, if needed.

**Agenda Topic:** Discussion on removing the building at 33825 Grand River

<u>Proposed Motion</u> Move to enter into proposed agreement to demolish the main building at 33825 Grand River along with the small building.

**Background:** The City enlisted OHM Advisors to help get quotes for the demolition of the city owned property at 33825 Grand River. Representatives from OHM and city administration met with Milford Salvage Iron & Metal Co. Inc. to discuss the specifics relating to the removal of the main building and the smaller (shed) building and to allow the contractor to go inside the building to get a better look at the basement.
