The Farmington Public Safety Department is proud to present the 2014 Annual Report. The report will provide you with a review of crime data, major case summaries, community policing programs, new technologies and an overview of the public safety department.

A new public safety director, four (4) personnel promotions, three (3) new hires, twelve (12) hour shifts. These are just some of the events that made 2014 an exciting year for the public safety department. Among all this reorganization, the department remained committed to its mission to deliver superior public safety services to the community. This commitment to the mission is clearly evident in the crime rate data for 2014.

"Part A" crimes (most serious) decreased 4.64% in 2014. This decrease is remarkable considering that it follows a 17.8% decrease in "Part A" crimes in 2013. Also remarkable is the fact that serious crime in the City of Farmington has decreased 44% in the last ten (10) years. We attribute this success to the hard working men and women of the public safety department and the support of city administration and the residents of Farmington. Some other notable crime decreases in 2014 are as follows:

- Burglaries decreased 43.4% (lowest in ten years)
- Larcenies decreased 11%
- Traffic crashes decreased 12.5%

Medical and fire operations continue to be valuable services to the community. The department responded to 136 fire related calls for service (137 in 2013) and 931 sick/injured complaints, up 23.8% from 2013. There were no fire related injuries or deaths and there were no fatal motor vehicle accidents in 2014.

The men and women of the Farmington Public Safety Department continue to strive to exceed the standards of professionalism, courtesy and superior services that are expected by residents and visitors of Farmington. The department remains committed to community partnerships in addition to pursuing proactive strategies to enhance law enforcement, fire safety, and medical services. The department is proud of its role in keeping Farmington a wonderful place to live, work and visit.

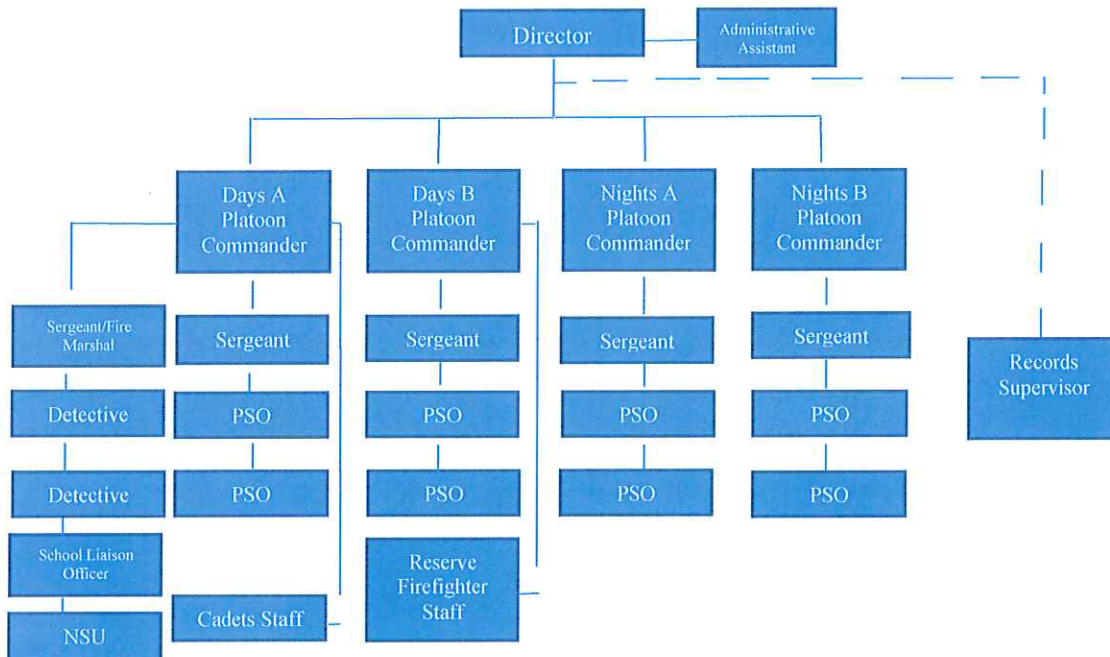

DEPARTMENT ACCOMPLISHMENTS



DEPARTMENT ACCOMPLISHMENTS (2014)

- ❖ There were no fire related deaths.
- ❖ No public safety personnel were seriously injured or killed in police or fire activities.
- ❖ Serious “Part A” crime decreased 4.6% in 2014. This decrease follows a 17.8% drop in 2013.
- ❖ One hundred sixty-four (164) fewer “Part A” crimes occurred in 2014, compared to 2010. This is a 43% reduction in five (5) years.
- ❖ Total number of residential burglaries decreased to nine (9) in 2014. This is the lowest in the last ten (10) years.
- ❖ The public safety department conducted over twelve hundred (1,200) Apartment Watch patrols conducted by vehicle, bicycle and foot patrols.
- ❖ Traffic crashes decreased by 12.5% and there were no fatal car crashes in 2014.



COMMUNITY POLICING



COMMUNITY POLICING

The Farmington Public Safety Department embraces community partnerships that promote effective police and fire services. Seventy-three (73) special services and programs focus on youth, neighborhoods, roadways and the businesses in our community. New or revised programs in 2014 are noted in bold print.

ALCOHOL TESTING

In cooperation with the probation department at the 47th District Court, the public safety department is testing probationers for the use of alcohol each morning.

ANIMAL TRAPPING PROGRAM

The department loans animal traps to residents (returnable deposit fee).

APARTMENT WATCH PROGRAM

The public safety department received a COPS Hiring Recovery Program (CHRP) grant to replace a vacant public safety officer position. The department has increased police patrols, bike patrols and foot patrols in the city's thirty-four (34) multi-housing communities. Monthly crime prevention presentations are part of the program.

AUTO IMPOUND

Public safety officers electronically complete impound paperwork when impounding vehicles, which automatically sends the necessary information to the tow companies.

BICYCLE SAFETY EVENTS

The Farmington Public Safety Department, along with LOC Federal Credit Union and AAA, sponsors bicycle safety events. The department also sells bicycle licenses to help identify lost or stolen bicycles.

BLOCK PARTIES

Department personnel visit neighborhood block parties with police cars and fire trucks, and distribute crime and fire prevention materials.

BUSINESS WATCH

Special meetings, programs and crime alerts are coordinated with the members of our business community.

CADET PROGRAM

This program started in 2012 due to the combining of dispatch services with Farmington Hills. The Cadet program staffs the front desk of the public safety department during nights and weekends. Cadets are individuals who have expressed an interest in becoming



Public Safety Officers and typically are pursuing a college degree.

CHILD CAR SEAT SAFETY INSPECTION

Citizens can have their child's car seat inspected for safety, proper installation and compliance with state law by the department's fire marshal who is a graduate of the National Child Safety Certification program.

CITIZEN AWARD RECOGNITION PROGRAM

The department recognizes members of the community who assist the public safety department.

CIVIC ORGANIZATIONS

Members of the department participate in thirty-eight (38) community and professional organizations.

CLICK IT OR TICKET

In addition to regular seat belt enforcement, the department participates in annual Memorial Day selective enforcement initiatives. Such initiatives save lives, reduce injuries, and help keep Michigan ninety-four percent (94%) compliant.

COMMUNITY COALITION WORKSHOPS

Members of the department participate in substance abuse and relationship violence workshops and programs.

COMMISSION ON CHILDREN, YOUTH & FAMILY

The department participates in the community commission and their events that promote the children, youth and families of our community.

COMPLIANCE CHECKS

The department conducts several annual alcohol and tobacco operations to discourage sales to minors.

CRIME ALERTS

The department expanded the capabilities of the department's crime alert notification system by utilizing Nixle software. Residents can now choose to receive text messages or Twitter communications. The public safety department can now send photographs and area messages with the alerts.

CRIMEMAPPING.COM

Citizens can log onto www.crimemapping.com to view up to date crimes that have occurred in their neighborhood.

CRIME PREVENTION NOTICE PROGRAM

Public safety officers issue crime prevention notices and warnings to residents. Examples include warnings issued to residents who leave valuables unattended, doors unlocked or garage doors open.

CROP WALK

The department coordinates participation and the safety of three hundred (300) annual walkers who raise money for the needy.

CROSSING GUARD PROGRAM

The department hires, manages and conducts annual training for school crossing guards at designated schools.

DECOY CARS

The department strategically places unoccupied patrol vehicles on streets to deter speeding and in business areas to discourage crime.

DRUG TAKE BACK PROGRAM

Residents can take their old prescription drugs to the public safety department (24 hours a day, 7 days a week) and have the drugs destroyed safely.

DTE STREET LIGHT DETAIL

In cooperation with Detroit Edison (DTE), public safety officers check all the street lights in the city each month and report any outages to DTE for repair.

E-CRASH

Public safety officers electronically complete accident reports. Motorists and insurance companies can obtain copies of the reports electronically or they can still obtain a copy by visiting our record's department Monday through Friday from 8:00 a.m. to 4:00 p.m.

FARMINGTON YOUTH ASSISTANCE

Department members attend board meetings and make appropriate referrals as an alternative to criminal prosecution.

FIRE INSPECTION PROGRAM

The department is proactive in conducting fire inspections to reduce loss of life and property.

FIRE SAFETY/PUBLIC EDUCATION PROGRAMS

The department conducts various fire safety education programs to pre-schools and other community groups.

FIRST AID, EMERGENCY PROGRAM

The department participates in several educational programs such as the Emergency Preparedness Commission.

FOOT BEAT PATROLS

Public safety officers are assigned to foot patrols in the downtown center and at special events.

FRAUD-NET

Detectives fight fraud and bank crimes with an on-line database linking bankers and law enforcement officers. The partnership promotes crime prevention and helps solve crimes.

GUN LOCK GIVEAWAY PROGRAM

The department gives away free locks to residents to promote gun safety.

HALLOWEEN FESTIVAL, CANDY PATROL

The department participates in the safety coordination at special Halloween events. Special patrols target neighborhoods and officers give away Halloween treats.

HAZARDOUS MATERIALS TEAM

Fire Marshal Madeline represents Farmington on the North Oakland County Hazardous Materials Response Team.

HOLIDAY ALCOHOL ENFORCEMENT PROGRAM

This award winning program utilizes public education, compliance operations, special patrols and partnering with several community organizations and the business community.

HOUSE CHECK PROGRAM

Residents may notify the department when their homes may be vacant for a period of time. The information is kept in dispatch and is helpful when the need arises to contact the homeowner should a crime or emergency occur.

INTERNSHIP TRAINING

College students or individuals interested in public safety who reside or work in Farmington may apply for internship training and education.

JAIL DIVERSION PROGRAM

Public safety personnel are trained to divert mentally ill prisoners into treatment facilities as an alternative to jail.

KNOX BOX PROGRAM

The department coordinates the installation of security boxes for elderly or handicap residents. The boxes contain keys to allow public safety personnel easy emergency access.

LOST AND FOUND ANIMALS

The department logs lost animal information to help locate owners when animals are found.

MABAS 3201

The department belongs to a multi-agency mutual aid agreement through Oakland County called the Mutual Aid Box Alarm System (MABAS). The mission of MABAS is to facilitate the mutual sharing of municipal fire service resources and ideas to provide members with a trained, equipped, and coordinated response for all hazards and technical operations beyond their local capabilities.

MiHAN

The department partnered with the Michigan Health Alert Network to electronically receive critical emergency public health information. Public safety officers utilize the information to properly respond to public health emergencies.

MISSING CHILDREN PROGRAMS

The department participates in child identification efforts. Policies and procedures are in place for quick activation of "Amber Alert" and "A Child Is Missing" programs. One thousand residents a minute can be notified by telephone to watch for a child.

MOUNTAIN BIKE PROGRAM

The department has three (3) mountain bikes used by officers at special events and during specific tactical operations.

MULTI-CULTURAL, MULTI-RACIAL COMMUNITY COUNCIL

The department is represented on the steering committee and participates in the philosophies and programs of this important group.

NARCOTICS SUPPRESSION UNIT (NSU)

Specially selected officers investigate illegal drug tips, execute search warrants and arrest drug offenders.

NEIGHBORHOOD WATCH

The department conducts monthly meetings with residents to teach crime prevention and provide crime updates. Special crime alert bulletins are delivered by community policing officers to neighborhoods experiencing crime.

OAKTAC

The Farmington Public Safety Department belongs to the Oakland County Law Enforcement Tactical Response Coordinating Group, commonly known as OAKTAC. This is a multi-agency group that provides free training to the department as well as being a resource that the department can call upon to assist in handling civil disturbances, active shooter, and other homeland security incidents.

OK2SAY

OK2SAY's focus is on early intervention and prevention, acting as an early warning system to thwart school tragedies before they occur. OK2SAY allows students (and others) the ability to submit tips 24/7 by telephone, text, email, mobile application, and via a web-based form on the OK2SAY web site, www.michigan.gov/ok2say or through text messaging at 652729 (OK2SAY).



OPERATION SAFE RIDE

The department partners this project with Mothers Against Drunk Driving to coordinate safe rides home for individuals consuming excess alcohol on New Year's Eve.

PARADE COORDINATION

The department participates and ensures community safety at the Little League Parade, Homecoming Parade, Memorial Day Parade, the Festival of Lights and Founder's Festival Parade.

PARENT FORUMS

The department partners with Farmington Public Schools to present annual crime prevention programs at parent educational forums.

POLICE BENEVOLENT ASSOCIATION

The Farmington Public Safety Department, Farmington Hills police and fire departments and the Franklin Police Department hosts an annual golf outing, dinner and raffle, as well as live and silent auctions. The event raises funds to assist public safety personnel, their families and members of the general public during times of death, illness or personal crisis.

PRIVATE PROPERTY ACCIDENT PROGRAM

The department responds to private property vehicle crashes, preserves the peace and records the facts on a police report.

PUBLIC SAFETY TOURS AND PRESENTATIONS

The department provides tours of the public safety building, vehicles, and responds to public safety requests for speakers and presentations.

RECRUITMENT PROGRAM

The department actively recruits officer candidates at universities, colleges and academies. Applications are released throughout the year.

RESERVE FIREFIGHTER PROGRAM

The department recruits, screens and trains members of the community who supplement fire and civil defense protection.

SCHOOL LIAISON OFFICER PROGRAM

This successful program has serviced all Farmington public schools since 1990. Officer Christine Schutz is assigned to Farmington High School. She provides on-site support to school administration, provides classroom instruction, serves as a connection with students, provides special presentations to parent groups, serves on various school committees, conducts crime prevention and enforcement, and investigates criminal matters occurring at the school.

SCHOOL SAFETY PROGRAM

The department is prepared to respond to all types of school and community emergencies. The Farmington Safe Schools committee and department personnel meet regularly and discuss concerns and safety issues. The public safety department maintains special equipment in each patrol vehicle should a serious incident require a rapid response.

SELECTIVE ENFORCEMENT PROGRAM

Patrol officers conduct weekly selective traffic enforcement details at various locations throughout the city, several at the request of residents.

SERVICE COMPLIANCE PROGRAM

The department promotes professional traffic stops and maintains a formal complaint procedure. The department also utilizes in-car cameras to verify professional conduct and re-create a factual record of public contacts.

SMOKE ALARM GIVEAWAY PROGRAM

The department provides free, battery operated smoke detectors to residents of the community.

SOBRIETY COURT HOME VISIT PROGRAM

Commander DuLong, Sergeant Friess, PSO Schutz, Sergeant Morche and Sergeant Wash visit the homes of residents arrested for drunken driving to encourage sobriety.

SPECIAL EVENT COORDINATION

The department plans and coordinates public safety personnel for special community events. Special operational orders are written defining department procedures. As an example, the department assisted Lifetime Fitness with their second annual "Commitment Day" run on January 1st, 2015 by directing traffic and helping with set up of the course.

SPECIAL PATROL PROGRAMS

The department identifies areas for special tactical patrols of uniformed or plain clothes officers. The department also honors requests for special attention patrols from residents and business owners.

SPEED TRAILER PROGRAM

The department identifies areas requiring "speed awareness" and "deterrence." A strategically placed trailer informs passing motorists of their speed. The department honors reasonable suggestions for trailer placement from residents and business owners.

START

The department participates in the Safe Therapeutic Assault Response Team. Investigators are partnered with specially trained forensic nurses to collect sexual assault evidence and counsel sexual assault victims.

TEDDY BEAR GIVEAWAY PROGRAM

The department stocks donated teddy bears to give to children who are involved in traumatic events.

TURN AROUND PROGRAM

Students at Farmington schools who turn their lives around in a positive manner are honored at an annual banquet. The department is a major sponsor and members serve on the planning and nominations committees.

VEHICLE LOCK OUT PROGRAM

Public safety officers respond to assist citizens locked out of their vehicles.

WASTE WATCH

The department partnered with community Waste Management workers who are trained to act as extra eyes and ears to report crime.

WEATHER EDUCATION PROGRAM

The fire marshal coordinates weather and tornado alert publications for free distribution to the public. The department also promotes public education and notification during tornados and severe weather alert month.

TECHNOLOGY ENHANCEMENTS

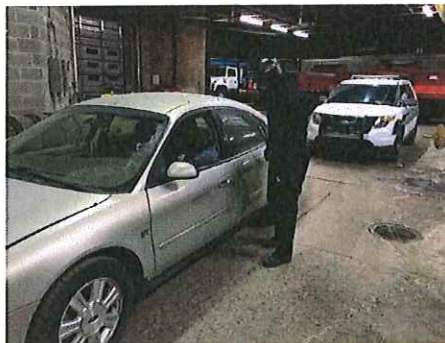


TECHNOLOGY ENHANCEMENTS

The Farmington Public Safety Department added five (5) new technologies in 2014, five (5) technologies in 2013, one (1) technology in 2012, one (1) technology in 2011, six (6) technologies in 2010, and six (6) in 2009. Twenty-four (24) new technologies have been introduced in the past six (6) years to enhance public services.

The public safety department added the following technology in 2014:

- **M-16 Rifles:** Through the Federal Government's 1033 program the department was able to obtain six (6) M-16 rifles at no cost to the department to enhance the department's active shooter response program.
- **Simunition Fx training weapons:** The department was able to purchase a new Glock 17T training pistol and two (2) M4 training conversion bolts to supplement the departments force on force training program. These items use the Simunition Fx training ammunition which allows officers to use real firearms which shoot paintball like marking projectiles for absolutely realistic training.
- **Simunition Fx Protective Gear:** New masks, helmets, and throat protectors were purchased to protect officers while they are engaging in the realistic force on force training utilizing the Simunition Fx marking rounds.

- **Desktop Computers:** The department purchased three (3) HP desktop computers to replace three (3) old Dell computers.
- **Computer Aided Dispatch:** Farmington Public Safety and Farmington Hills Police became pilot agencies for the new CLEMIS Computer Aided Dispatch (CAD) program in both the cars and at the department.

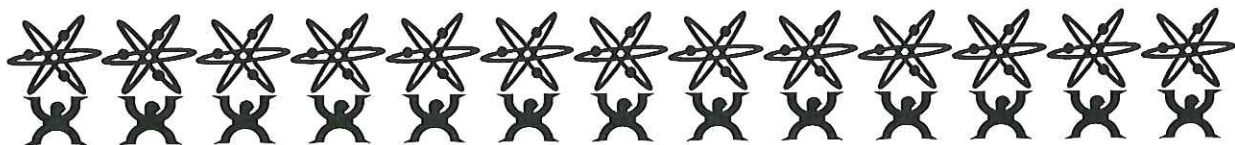

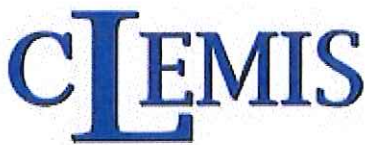
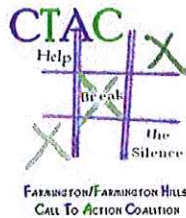
Public safety administration is commanded by Director Frank Demers and assisted by Administrative Assistant Carole Lukas.

PATROL DIVISION



PATROL DIVISION

The uniform patrol division consists of four (4) platoons working twelve (12) hour shifts. In May 2014, the patrol division changed from eight (8) hour shifts to twelve (12) hour shifts. There are two (2) platoons that work alternating day shifts and two (2) platoons that work alternating night shifts. Each shift consists of a commander, sergeant and two (2) public safety officers. The patrol division is led by commanders Ted Warthman, Justin DuLong, Bob Houhanisin, and Todd Anderson. The commanders are assisted by sergeants Jeff Brow, Richard Friess, Andrew Morche and Shane Wash. There are eight (8) officers assigned to the patrol division. Richard Hennessy (ret.) Scott Herrmann, Aaron Malewski, Alan Baranski, Mark Keeley, Patrick Spelman, William Wood, and James Wren.

The patrol division saw many changes in 2014. Commander Terrence Purves and PSO Richard Hennessy retired. Bob Houhanisin and Todd Anderson were promoted to commander. Andrew Morche and Shane Wash were promoted to sergeant. Mathew Miracle was hired as new public safety officer.

Six (6) cadets allowed for the department to remain open for twenty-four (24) hours, seven (7) days a week. The cadets work eight (8) hour shifts and are typically the public safety department's first point of contact with citizens at the front desk. The cadets interact with the public, answer phones, assist with records, clean the station, assist officers with booking prisoners, and feed prisoners. A vital role of the cadet is to maintain the department's jail. This is important because it allows the officers to remain in the City of Farmington instead of having to lodge prisoners at another facility. The cadets are also trained in the use of Computer Aided Dispatch (CAD) and Law Enforcement Information Network (LEIN). They process LEIN messages and CAD runs for desk complaints. The cadet staff consists of Alicia Trotter, Paul Hughesdon, Chris Saunders, Eric Harris, Heather Silcott and Matthew Council. Reserve Firefighters John Dresden and Sean Skinner fill in when a cadet is not available to work.

The patrol division prides itself on providing excellent police, fire and medical services. Quick response time allows for public safety officers to mitigate emergencies quickly and efficiently, reducing the potential for further harm. The patrol division conducts an "Apartment Watch" program. Officers routinely patrol the apartment complexes within the city which result in arrests and prevent crime. During "Apartment Watch" patrols, officers have made arrests for drug possession, open alcohol, warrants, damage to property and prowling. The "Apartment Watch" program has been credited with lowering crime rates and keeping our apartment communities safe.

The patrol division continues to be aggressive with traffic enforcement. Officers make traffic stops, issue citations, and enforce commercial vehicle laws. In addition, patrol officers make drunken driving arrest, suspended driver's license arrests, warrant arrests, and drug arrests, all in an effort to keep the streets safe. The patrol division is

also charged with performing “selective enforcements”. These are conducted in residential areas where citizens feel there is a problem with speeding vehicles. Officers also deploy the department’s speed trailer which is affectionately referred to as SMARTY (Speed Measurement Radar Trailer). Residents can request a target area for a week long deployment of SMARTY.

Officers regularly patrol subdivisions within the community. Officers issue crime prevention notices, otherwise known as “blue cards”, when they find a situation where a resident has left themselves vulnerable. Officers look for open garage doors, dark homes, bikes left on the front lawn and other potential “soft target” situations in an effort to prevent a resident from becoming a victim of a crime of opportunity. The “blue card” program has received many compliments from residents. Other services the patrol division provides are home/vehicle lockouts, picking up stray animals, visiting block parties, and providing station tours. The patrol division is dedicated to providing exemplary public safety services, with empathy and professionalism.

SPECIAL OPERATIONS

The Officer-in-Charge of the Special Operations Unit was Commander Frank Demers until his promotion in October of 2014. The Special Operations Unit is now supervised by the two day shift road commanders. The Special Operations Unit consists of Detective Andrew Morche, Detective Scott Brown, and School Liaison Officer Christine Schutz. The Fire Marshal, Sergeant Reginald Madeline, is also assigned to the Special Operations Unit.

Special Operations personnel are responsible for some of the following functions: criminal investigations, evidence technician services, crime scene photography, fire inspections, fire equipment maintenance, full-time officer background investigations, reserve firefighter background investigations, cadet background investigations, Neighborhood Watch, evidence and property room management, school liaison program, solicitor permits, safety presentations, and compliance operations for alcohol, tobacco and massage facilities.

In 2014, Special Operations personnel received specialized training in the following topics: cell phone investigations, juvenile justice training, basic investigator school, Leads Online Investigator Training, Using Social Networks as an Investigative Tool, and CLEMIS Cool Tools training.

Narcotics Suppression Unit

The success of the Farmington Narcotics Suppression Unit (NSU) have been the result of the collaborative efforts of concerned community members coming forward with drug

related tip information, and the drug related arrests made by dedicated department personnel.

In 2014, Farmington NSU officers investigated nine (9) narcotics tips, along with conducting several interviews of persons arrested by this department for possessing illegal drugs. Farmington NSU officers continue to focus on developing information and intelligence on known drug activity and sources effecting our city and surrounding community.

Farmington NSU strives to work with the community, along with regional drug task forces, to suppress narcotic activity and other crimes in the City of Farmington.



FIRE SERVICE

Fire Marshal Reginald Madeline oversees the department's fire and medical operations. As a part of his regular duties, the fire marshal conducts fire inspections, schedules and performs maintenance on the department's fire apparatus and coordinates monthly fire fighting and medical training. All sworn personnel are certified firefighters and medical first responders. Four (4) members of the department have advanced medical training and are licensed emergency medical technicians. Additional services provided by the department's fire service include; fire extinguishment, hazardous materials response, smoke detector give-away program, public education seminars on fire safety, first aid, infant/child safety seat inspections and the commercial/residential Knox Box program. Due to quick response times and quality training, the total fire loss in 2014 is estimated at \$125,000.00.

TRAINING PROGRAMS



TRAINING

The public safety department continues to seek out training opportunities for both sworn and civilian personnel to increase both knowledge and practical skills. The following pages are the training courses personnel attended during 2014:

POLICE TRAINING

- **General Commercial Motor Vehicle Enforcement:** A two day class, sponsored by the Brownstown Police Department, focusing on general enforcement duties with regards to commercial vehicle enforcement.
- **Basic Cell Phone Investigations:** A free two day class, sponsored by the National White Collar Crime Center, helps investigators better understand cell phone analysis and evidence
- **Microsoft Excel Levels 1 & 2:** A two day class, sponsored by the Oakland Police Academy, teaching the basics of Microsoft Excel.
- **Commercial Motor Vehicle Interdiction Training:** A three day class hosted by the Livingston County Sheriff's Department and the United States Department of Transportation that concentrates on tactics and techniques unique to commercial motor vehicle enforcement.
- **Leadership in Police Organizations:** A three week leadership development class, sponsored by the Michigan State Police, focusing on all aspects of police administration.
- **Oakland County Juvenile Justice Orientation:** A one day class, hosted by the Oakland County Prosecutors Office, that gave the student an overall review and update of juvenile justice laws and case management for Oakland County agencies.
- **GLOCK Pistol Troubleshooting:** A one day class hosted by the Farmington Hills Police Department that addresses maintenance issues related to our department service weapon.
- **Basic Investigator School:** A four day class designed for the new detective that covers such topics as search and seizure, forensics, and intelligence gathering.

- **GLOCK Armorer Course:** A one day class, sponsored by our department, that certifies an officer to perform maintenance and advanced functions on our department weapons.
 - **Leads Online Investigative Training:** A one day class that teaches students all about a new database surrounding the pawn business.
 - **Identity Theft Training:** A two day class, hosted by the Internal Revenue Service, that focuses on the crime of identity theft and investigative techniques that may be helpful to investigators.
 - **Field Training Officer School:** A three day class, hosted by the Oakland Police Academy, that prepares the veteran officer with a system for teaching new police officers when they are hired.
 - **Fair and Effective Discipline:** A two day class, hosted at the Troy Police Training Center, that focuses on labor law and sound management principles regarding discipline.
 - **Using Social Networks as an Investigative Tool:** A two day class focusing on a host of social media websites, such as Facebook, Instagram, and Twitter along with some investigative techniques for each.
 - **CLEMIS Cool Tools:** A free one day class that teaches officers about advanced techniques that can be used by officers for investigative purposes.

FIRE TRAINING

- **Compressed Gas Emergency Response Containment:** A two day class for Oakland County Hazmat Team members that focused on the proper response to compressed gas emergencies.
- **Firefighter Right to Know:** A one day class sponsored by the Southeast Michigan Fire Inspectors that explained the requirements of Michigan's Firefighter Right to Know Law.
- **Firefighter Safety and Leadership Conference:** A three day course that concentrates on the key leadership and safety issues facing today's fire service.
- **Educational Methodology:** A one day course that gives the participant an introduction to teaching in the fire service.
- **Firefighter Instructor Orientation:** A required one day class, sponsored by the Michigan Fire Fighter Training Division, for fire instructor certification.

- **Child Passenger Safety Seat Workshop:** A one day course that focuses on seat belt law changes, safety recalls of child car seats, and new techniques for proper installation of child car seats.
 - **Forcible Entry 1:** A one day class that teaches the participant the easiest and safest ways to make entry into locked or secured locations using force.
 - **Fire Extinguisher Training:** A one day class that focuses on the requirements of different building classifications in having fire extinguishers on site and the type they are required to have.
 - **Live Burn Training:** All department members completed live burn training at a burn building located at the Wixom Fire Department.
 - **National Fire Incident Reporting System:** A free two day class, hosted by Oakland Community College, that informs the student how to enter required fire statistics and information for required monthly reporting.
 - **CPR Instructor Recertification:** A free one day class that recertifies the attendee to teach CPR.

2014 GRANTS & COMMUNITY PARTNERSHIPS

The department had no grant activity during 2014. However, the department partnered with area businesses to sponsor community events to provide safety information and strengthen community relations with the department.

CAR SEAT SAFETY INSPECTIONS

The public safety department partnered with LOC Federal Credit Union and “Safe Kids” of Macomb County to provide car seat safety inspections. Approximately thirty (30) child seats were inspected for proper installation. This annual event is held the first Saturday in June at LOC Federal Credit Union (Farmington branch). The event is free to all who are interested.



FIRE SAFETY PROGRAM

The public safety department once again partnered with Farmington Hills Fire Department for a fire safety program titled “Fire Safety with the Superheroes.” This program was shown to a total of fourteen (14) elementary and middle schools in the Farmington Public School District. It reached approximately 5,800 students and 280 faculty members and parents. The program covered fire safety topics such as: “Stop, Drop and Roll”, Don’t Play with Matches or Lighters, 9-1-1, smoke alarms, “Don’t Hide, Go Outside”, Two Ways Out, escape plans, meeting place and “Once Out, Stay Out.”

HEROES & HELPERS EVENT

Members of the department were honored to participate in the Heroes & Helpers event at Target. The program is offered to less fortunate families in the Farmington/Farmington Hills community to ensure that their children have gifts for the holidays.



9/11 MEMORIAL CEREMONY

The 9/11 memorial, a dark granite slab, designed by S3 Architects, which holds an artifact from the World Trade Center destroyed on Sept. 11, 2001, was revealed to a crowd of some seventy-five (75) residents on the grounds of city hall at 8:46 a.m. on September 11th, precisely the time terrorists crashed a jetliner into the first tower and set off a wave of events that would forever change our way of life. Councilman Steve Schneeman, Director Robert Schulz, DDA representative Bob Rock and a host of other volunteers helped raise funds to design and build the memorial.



MAJOR INCIDENTS



2014 MAJOR INCIDENTS

The following incidents are a synopsis of major incidents receiving community wide attention in 2014.

MARCH 15, 2014-CARRYING CONCEALED WEAPON

An officer on patrol stopped a vehicle for a traffic violation. Upon further investigation, the officer noted open intoxicants in the vehicle in plain view. The driver had an odor of intoxicants, along with a large amount of currency (\$12,032) in the glove-box of the vehicle which the officer observed when the driver opened it to retrieve his vehicle paperwork. The investigating officer conducted field sobriety evaluations on the driver, who was subsequently arrested for OWI. Upon conducting an inventory of the vehicle, a fully loaded .25 caliber semi-automatic handgun was found inside along with brass knuckles, and suspected Marijuana. The driver had prior convictions for Felony Dangerous Drugs, Felony Weapons-Carrying Concealed, and Delivery/Manufacture Dangerous Drugs. The driver was subsequently charged with Felony Firearm-Possession by Felon, Carrying Concealed Weapon, and Dangerous Weapon.

APRIL 09, 2014-COMMERCIAL BREAKING & ENTERING

Officers responded to a commercial office building on Drake Road on a report of a Breaking and Entering. Upon arrival, a tenant stated that he arrived to find that the building had been broken into. The tenant reported that a total of four (4) suites had been broken into with the suspect(s) stealing several flat screen televisions along with a laptop computer. A tenant on scene reported that the custodial staff was the last persons in the building prior to the incident. The case was forwarded to the Detective Bureau for further investigation. The investigation is ongoing.

MAY 21, 2014-TERRORIST THREATS ARREST

An officer working the front desk at the station received a phone call from an unidentified male who stated that he had planted a bomb at Farmington High School and it was going to detonate in the morning. The caller then disconnected. Efforts to trace the call were unsuccessful. As a precaution, the department enlisted the help of a Michigan State Police K-9 team who searched the school and surrounding grounds finding no evidence of a bomb. As a further precautionary measure, officers assisted Farmington High School administrators by searching the bags of every student prior to entering the building.

The case was turned over to the school liaison officer who conducted an extensive investigation to identify the caller. After conducting numerous search warrants for internet phone service providers, a seventeen (17) year old Farmington Hills resident and Farmington High School student was identified as a suspect. Investigators interviewed the suspect who confessed to arranging the bomb threat call with some

other individuals with whom he had dealings with on the internet. The suspect was arrested and subsequently charged with False Report and Threat of Terrorism. Through investigation, investigators identified the two accomplices whom the suspect advised helped facilitate the threat. It was learned that the accomplices were responsible for other bomb threats called into buildings in Florida and New York. Investigators shared the information they developed with investigators from those states. As a result, the accomplices were identified, arrested and charged.

JUNE 6, 2014-HOME INVASION

Officers responded to a residence on a report of a home invasion that had just been discovered. Upon arrival, officers met with the resident whom stated he arrived home from school to find the front door of the residence had been kicked in and the home had been ransacked. The resident's mother (homeowner) arrived on the scene and found a large screen television missing along with clothing, money, and a Wii game system. Officers processed the scene, but were not able to recover any evidence. The case was forwarded to the Detective Bureau for further investigation. The case remains open as there have been no further leads toward identifying the suspect(s).

JUNE 13, 2014-AGGREGATED/FELONIOUS ASSAULT ON POLICE OFFICER

An officer was on patrol and attempted to stop a vehicle/driver for a traffic offense. Upon making contact with the driver, the driver refused the officer's requests for him to roll down the window of his vehicle. The officer could smell an odor of intoxicants coming from the vehicle. After several more attempts to have the driver roll down his window, the officer requested the driver exit his vehicle. The driver refused and instead attempted to drive off nearly striking another officer. The officer, along with backup officers, had to break the driver's side window of the vehicle in order to get the driver out. The driver continued to actively resist officers while they were handcuffing him. One of the officers sustained a hand injury during the incident. The driver was subsequently arrested and charged with Fleeing & Eluding - 3rd degree, Assault with a Dangerous Weapon (Felonious Assault), Assault/Resist/Obstruct Police Officer Causing Injury, Assault/Resist/Obstruct Police Officer, and Operating Motor Vehicle While License Suspended/Revoked/Denied.

SEPTEMBER 3, 2014-STOLEN/RECOVERED BICYCLES

Three (3) bicycles were reported stolen from the driveways of homes in the Bel-Aire subdivision. The cases were turned over to the Detective Bureau. Through investigation, detectives learned that one of the bikes had been pawned for cash at a local resale store. Working with the resale store manager, investigators were able to identify the suspect, who provided a Detroit home address on the pawn slip. Through further investigation, detectives were able to determine that the suspect actually resided in a home in the Bel-Aire subdivision. Detectives went to the suspect's home to interview him. As they pulled up to his residence, they observed a man who appeared to be the suspect riding one of the bikes that was reported stolen. Investigators interviewed the man who confessed to stealing all three bikes. Investigators were able to recover the other bikes and return them to their owners. The suspect was subsequently charged with three counts of theft.

SEPTEMBER 29, 2014-HOME INVASION

A resident reported a home invasion after she noted that her mother's jewelry was missing from the residence. The resident stated she suspected her adult son, as he has a history of stealing jewelry to support his Heroin addiction. The resident stated she had already confronted her son about the crime, and that he confessed to it. The resident stated she wanted to press charges against her son for Home Invasion. The suspect was interviewed and subsequently confessed to the Home Invasion, stating that he pawned the jewelry for \$286.00 to support his drug addiction. The Oakland County Prosecutor's Office issued a warrant charging the suspect with Home Invasion.

OCTOBER 18 TO NOVEMBER 2, 2014-HOME INVASIONS FLORAL PARK SUB

Officers responded to three (3) home invasion reports at vacant residences in the Floral Park Subdivision all within a week of one another. Officers met with the homeowners, all of whom stated that their homes were vacant and up for sale. The homeowners stated that when they went to check on their homes, they found evidence of possible squatters having lived there. Upon further investigation and help from an alert resident in the area, a suspect was found lurking near a vacant residence on November 2nd. Patrol officers located the suspect who revealed that he was homeless and was breaking into the homes for warmth and shelter at night. The suspect was arrested and subsequently charged with multiple counts of home invasion.

NOVEMBER 5, 2014-4TH DEGREE CRIMINAL SEXUAL CONDUCT

An officer on patrol came upon an occupied vehicle behind the old K-Mart at Grand River & Halsted Road. Upon further investigation, it was found that the victim in the case, who is fifteen (15) years old, had met the other twenty-one (21) year old occupant of the vehicle on a cell phone app called "Whisper". The victim stated that she and the other occupant had been involved in a sexual act while parked behind K-Mart when the officer pulled up behind them, and illuminated the vehicle with a spot light. The twenty-one (21) year old occupant was arrested for Criminal Sexual Conduct (CSC). The fifteen (15) year old juvenile was turned over to his parents at the station. The twenty-one (21) year old was charged with CSC 4th Degree and the case is pending trial.

NOVEMBER 26, 2014-ARMED ROBBERY OF BUSINESS

Officers responded to a report of an Armed Robbery at a business on Orchard Lake Road. Upon arrival, officers were advised by witnesses that the suspect fled to a residence on Lee Lane. Officers were able to make contact with the occupants at the Lee Lane residence and a subject matching the description of the suspect was inside along with other evidence from the scene. The suspect was arrested for Robbery-Armed. The case is currently awaiting trial in Oakland County Circuit Court.
