# FARMINGTON CITY COUNCIL SPECIAL MEETING

A special meeting of the Farmington City Council was held on Wednesday, November 14, 2007, in Council Chambers, 23600 Liberty Street, Farmington, Michigan. Notice of the meeting was posted in compliance with Public Act 267-1976.

The meeting was called to order at 7:35 p.m. by City Clerk Halberstadt.

#### **OATH OF OFFICE**

City Clerk Halberstadt administered the oath of office to newly elected Councilmembers JoAnne McShane, Valerie S. Knol, and David J. Wright.

# **ELECTION OF MAYOR**

City Manager Pastue called for nominations for Mayor.

In response to a question from Councilmember Buck, City Attorney Schultz reviewed the mayoral responsibilities.

Councilmember McShane nominated Valerie Knol for Mayor.

Councilmember Wright nominated Tom Buck for Mayor.

Hearing no further nominations, City Manager Pastue closed the nominations.

Councilmember Buck requested discussion before taking a vote. He asked Knol regarding her position on the consolidation effort with Farmington Hills.

Councilmember Knol responded by stating the study is important because it will provide residents with factual and objective data from a third party. She discussed the future economic challenges the cities will be facing. She spoke about increased efforts by the State to promote cost sharing and revenue cutbacks. She stated the city must be proactive in looking for ways to save money. She noted that she is not necessarily in support of a full consolidation, but emphasized that the city must explore cost sharing opportunities.

### COUNCIL PROCEEDINGS -2-November 14, 2007

Knol spoke about Farmington's positive relationship with Farmington Hills and the possibility for that relationship to expand and improve.

Knol stated she could not support an increase in shared services or a full consolidation until the facts are known. She spoke about the variety of opinions she has heard from residents regarding consolidation and the steps the city is taking to provide opportunities for resident feedback.

Knol noted that all Councilmembers voted for the consolidation study. Responding to an additional question, she stated if a decision needed to be made today she would not vote for consolidation, but stressed that there is not enough information currently available to make an informed decision. She emphasized the importance for Councilmembers to have an open mind to the results of the study.

Councilmember Buck expressed his appreciation to Knol for her feedback. He stated the Mayor's position should be one that supports the city's autonomy until residents have indicated otherwise. He expressed his wish that the city had obtained feedback from residents prior to embarking on the consolidated study.

Responding to a question from Councilmember Wright, Buck stated the consolidation study is important in terms of providing additional data for sharing services. He stated if he had to vote today his vote would be for Farmington's autonomy.

A roll call vote was taken resulting in unanimous support for Valerie Knol as Mayor.

## **ELECTION OF MAYOR PRO TEM**

Mayor Knol called for nominations for the Office of Mayor Pro Tem.

Councilmember Wright nominated Councilmember Buck for the Office of Mayor Pro Tem.

Hearing no further nominations, Mayor Knol closed the nominations and declared unanimous support for Councilmember Buck as Mayor Pro Tem.
