## PETITIONS AND COMMUNICATIONS

**LETTER FROM MS. SHELLEY RAYMOND REQUESTING GROUND SIGN FOR BAKER STREET DRAPERIES AT 33432 OAKLAND STREET.** Administration advised that Ms. Raymond has requested a ground sign, 70" x 37.5" in size, with ground lights. Administration further advised that if Council wishes to grant permission to Baker Street Draperies for a ground sign, Council would need to grant a variance to Section 25-13, subsection 11 of the city sign ordinance.
