3. PUBLIC COMMENT

No Public Comment was heard.

4. LEGISLATIVE PRIORITIES

A. Legislative Priorities - Christine Greig, State Representative Present: Chris Greig, State Representative **4.**A

Newly elected State Representative, Chris Greig, spoke about her legislative priorities. She discussed some of the committees on which she would like to serve.

Greig entertained comments and questions from the Council.

Scott stated the reconstruction of Grand River Avenue should be a legislative priority.

Cowley discussed the lack of bank lending to small businesses that is stifling economic development.

Responding to a question from Schneemann, Greig stated one of the major challenges facing Farmington/Farmington Hills is school funding. She stated Charter reform and returning revenues to local government need to be addressed.

Cowley addressed proposed legislation to eliminate Tax Increment Financing (TIF) and how detrimental it would be to local government.

Galvin encouraged better dialogue regarding funding of roads and schools in the legislature. He urged Greig to reach across the aisle and make a concerted effort to address the issues.

Pastue talked about the importance of the Commercial Rehab District as an economic tool and noted it is scheduled to end. He would like to see this program extended.

Mayor Galvin thanked Greig for her visit and requested that she provide periodic updates to Council.

5. MICHIGAN MUNICIPAL LEAGUE CITY MANAGER SEARCH

A. Michigan Municipal League City Manager Search - Kathie Grinzinger Present: Kathie Grinzinger, Lead Executive Recruiter, and Jessica Reed,

Michigan Municipal League (MML)

Grinzinger discussed the search process that will take place in the recruitment of a City Manager. She advised the process includes: developing candidate and community profiles; recruitment and outreach campaign; screening and narrowing of applicants; reference review; and interview and selection process.

Grinzinger then opened the floor up for questions and/or comments from the councilmembers.

Responding to a question from Schneemann, Grinzinger stated typically the number of out-of-state applicants is 50%. She encouraged out-of-state recruitment and indicated certain leadership skills are transferrable from state to state.

Discussion followed regarding the 120-day timeframe for the recruitment process. Grinzinger detailed the process of allowing four weeks for all candidates to submit applications and her reasoning why. She stated the screening process is very time consuming and scheduling conflicts can also pose a delay.

Galvin stated his goal in the process is to develop a deep, rich talent pool of diversified candidates and welcomed out-of-state pursuits.

Discussion was held regarding developing interview questions. Grinzinger said the questions will be based on information from everyone involved in the recruitment process and the input received.

Galvin raised the issue of the screening process and what it entailed. Grinzinger detailed what was involved and the candidate information that would be made available. She stated information may be redacted for candidates requesting confidentiality.

Discussion followed regarding maintaining the confidentiality of candidates, but at the same time providing Council sufficient information in order to make an informed decision on final candidates.

Grinzinger discussed the timeline going forward and possible dates for the next meeting during which Council will review draft ad copy and establish salary and benefits for the City Manager position.

6. DISCUSSION FARMINGTON ROAD STREETSCAPE

A. Discussion - Farmington Road Streetscape Financing (Handout)

Pastue advised the estimated cost for the Farmington Road Streetscape has increased to \$2,589,010. He reviewed a list of alternatives that could be utilized to make up for the \$1,132,010 shortfall. He suggested the possibility of a \$1 million bond issue to cover the remaining costs.

Responding to a question from Cowley, Pastue advised the total budget for the Grand River Streetscape is \$2.2 million. Cowley questioned moving forward with the project given the increased cost, noting the City's priority is to generate TIF.

Responding to a question from Scott, Pastue stated the southern curb cut on the Chase site is not feasible, however, the curb cut at CVS Pharmacy is necessary.

Schneemann questioned the construction engineering cost.

Galvin pointed out the work that has gone into the project and noted all grant monies will be lost if the project is not done.

Schneemann stated the status of the curb cuts would play a big role in his decision, and that Council should have had that answer a year ago, especially with regard to CVS. He questioned what remains to be done on the project and the value of moving forward.

Cowley endorsed pursuing more TIF projects rather than limiting resources by funding this project. He would need to know what TIF generating projects he is giving up as a result of the streetscape project.

Pastue pointed out redevelopment of Farmington Road would promote other redevelopment projects in that area.

7. OVERVIEW OF FISCAL YEAR 2015-16 BUDGET

1. Overview of Fiscal Year 2015-16 Budget Process and Forecast (Handouts)

Pastue provided Council with a handout containing an overview of the Fiscal Year 2015/16 budget process and forecast. He detailed the line items and stated that proceeds from the Courthouse, Flanders and other projects would be put into the Capital Improvements Fund. He stated all in all it was a good budget with long term goals.

Galvin commented that having written financial policies would be an important tool.

8. OTHER BUSINESS

Pastue advised there needs to be a discussion on the topic of parking meters in the lot north of Grand River. He stated this will be an agenda item at the next DDA meeting. He commented on the benefit of parking meters for successful businesses that are hampered by tight parking areas. He suggested forming a committee to study this issue in order to move it forward.

Schneemann noted it would help if parking were allowed at The Village Shoe Inn.

Cowley indicated meters would change behaviors and should be expanded to include Grand River.

Pastue stated he would like to see a report from the Committee charged with studying the issue by sometime in April.

Scott commented that the Committee needs to look at the big picture when addressing this issue.

Galvin stated that the Committee goal should not be to manage fee-based parking, but free-based parking. He encouraged establishment of a Parking Committee to manage all of downtown parking.

Further discussion was held regarding how the revenues from the parking meters would be used. Schneemann expressed his support for a single kiosk per lot.

Rachel Gallagher, DDA Boardmember, noted parking patterns on Friday and Saturday evenings in the downtown show that the Talmer Bank and Cromwell parking lots are empty.

2014-2015 Work Plan

Pastue reviewed the remaining items to be completed from the 2014-2015 Work Plan:

- Under the topic of Community Development the item of evaluating residential zoning standards is moving forward with LSL making a presentation at the February 9th Planning Commission Meeting. It will then be reviewed at the March 2nd Study Session and a Public Hearing will then be held at the April 13th meeting. The ordinance will then be introduced at the May City Council meeting and adopted at the following meeting in June.
- A complete design concept of the entry/wayfinding/City facilities signs should be presented to Council at the March 2nd study session. If approved, bids will be solicited for work and installation. Approval of bids will occur at the April 20th Council meeting. The project should be completed sometime during the summer, preferably before June 30th.
- A complete Corridor Overlay District is projected for adoption at the January 20, 2015 Regular Meeting.
- Event Policy the final review is set for the February 2nd Study Session and consideration to adopt the policy is scheduled for the February 16th, 2015 Regular Meeting.
- Redevelopment Projects slated for completion with target dates:
 - Old Courthouse Property closing targeted for February
 - Flanders closing targeted for February
 - K-Mart Center (Commercial Rehab District) action targeted in Spring 2015

6. PRESENTATION/PUBLIC HEARINGS

A. Special Event Request - Thursday Night Weekly Swing Farmington

Alexander Steward, President of Swing Farmington, Inc., was present to request Council approval of a special event request to hold swing dancing on Thursday nights for the dates and times requested in the application. He further requested a waiver of the sound ordinance for the event. He stated his organization will pay \$25 a week to the City to offset maintenance costs. He noted the event brings in 200 young adults and people of all ages each week during the season. He welcomed questions from Council. Responding to a question from Schneemann, Steward advised the group utilizes St. John Lutheran Church as a back-up location when the pavilion is unavailable such as during Founders Festival.

Schneemann suggested that during Founders Festival the beer tent is not busy on the Thursday night of the Festival and thought that Swing Farmington would be a good fit. Steward said he would welcome the opportunity.

Cowley expressed concerns regarding maintenance and security for he event. He questioned whether an agreement was in place with the city concerning these issues.

Pastue responded volunteers with the group will maintain and clean-up after the event. He stated the group will pay \$25 each week to offset any maintenance costs. He noted Steward had consulted with former Director Schulz who provided advice from a Public Safety standpoint.

Cowley reiterated his concerns regarding unsupervised activity and stated he would like to see security on site on those Thursday nights.

McShane indicated there have been more problems with the beer tent during Founders Festival than the seven years Swing Farmington has been at the pavilion on Thursday nights. She advised Steward should take Cowley's comments into consideration. She encouraged him to keep the line of communication open with Public Safety and Director Demers. She praised him for being a positive role model for young groups in the community and encouraged him to continue in this role. She also offered the parking lot of Bellacino's as a possible back-up site for their group.

Responding to a question from Scott, Steward stated his group is developing relationships with several of the downtown businesses including: Starbucks, Off the Beaten Path, Basement Burger Bar, Dagwood's and Coldstone Creamery.

Motion to approve a special event request for Swing Farmington, Inc. scheduled every Thursday, May 1 through October 22, 2015, 7:30 - 11:30 p.m. with the following conditions:

- Music will discontinue at 11:00 p.m. except for evenings during the summer months;
- Waive the City Sound Ordinance to allow Swing Farmington, Inc. To extend operation until 11:30 p.m. from the end of the school year June; and
- Approve a charge of \$25/week to defray the cost of maintenance.

B. Farmers Market Annual Report - Walt Gajewski

Walt Gajewski, Market Master, provided a handout highlighting the 2014 Farmers Market and planned events for 2015. He reviewed items in the report including record revenues of almost \$53,000, with sponsors contributing \$18,000 of that amount. He thanked the volunteers, especially Susan Lightner, for their hard work and dedication. The handout detailed attendance and weather records for 2014, information on vendors and volunteers, community groups that participated as well as local businesses. He reviewed highlights of the 2014 Season and his goals for 2015. He requested Council consider participating in SNAP, Supplemental Nutritional Assistance Program; and entertain the idea of a midweek Farmers Market on Wednesdays from 3:00 - 7:00 p.m.

Responding to a question from McShane, Gajewski stated the Downtown Development Authority had conducted a study regarding the impact of the Farmers Market on downtown businesses.

Pastue indicated a majority of businesses had a favorable view of the market, but parking remains an issue.

McShane encouraged Gajewski to solicit businesses from all over Farmington to participate in the market.

Scott expressed his support for surveying visitors to the market to gain a feel for its impact on the region.

Schneemann inquired about the details of the mid-week market and discussion was held.

Cowley complimented Gajewski and his team on the success of the market. He also requested more data on the demographics of the people who came to the market.

Gajewski thanked Council for their recognition of the volunteers.

Mayor Galvin thanked him and Susan Lightner for their hard work.

C. Introduction of New Public Safety Officers

Director Demers formally introduced newly hired Public Safety Officers, Lisa Kobernick and Cody Hawkins, and provided a brief background on both. He then administered the Farmington Public Safety Code of Honor before City Council.

B. Consideration to Ratify City Manager Selection of Representatives to Serve on North Parking Lot Ad Hoc Committee

Pastue advised this item was discussed at the January 5, 2015 study session. He requested consideration to ratify the list of committee members as presented.

Scott expressed the importance of looking at the entire downtown when determining the impact of parking meters. He asked regarding the timeframe for this committee to provide information back to Council.

Pastue stated he would like to have the committee's report to Council in April, noting this will be a fast-tracked item.

Cowley stated at the first committee meeting they determined their greatest challenge is to facilitate employee parking. He advised a survey is being distributed to all business owners on Grand River.

McShane is glad to see this happening and supports finding short and long term solutions. She approves of the selection of the committee members, but believes it is top heavy with north lot businesses and would like to see other businesses and residents on it to give their perspective.

Pastue told everyone to keep in mind this is an Ad Hoc Committee, that they would like to set in place a long term parking committee going forward.

Galvin acknowledged the meetings are not be subject to the Open Meetings Act, however, he would like the public informed of the meetings and requested the agenda include an opportunity for public comment.

9. DEPARTMENT HEAD COMMENTS

Weber noted the use of parking meters would be another source of revenue and as a result create more work for his department. He reminded residents it is time to purchase dog licenses which are required of all dog owners. They can be purchased at the Treasurer's counter in City Hall or online at Oakgov.com. A valid rabies certification is needed. The cost is \$7.50 for spayed or neutered dogs and \$15 if not. After June 1st the price goes up to \$30.

Eudy stated they had closed out the last day for accepting applications for openings in the DPW. He said leaf season was effectively wrapped up and the staff has been involved in more training. Cowley complimented his team as he had witnessed them working in the bitter cold doing a water replacement.

Demers indicated in light of his representation on the Ad Hoc Committee he had done some research in Royal Oak and Rochester Hills regarding the use of parking meters. He advised Code Enforcement oversees the meters in Rochester Hills. He noted that one of the greatest rewards his department experiences is when a resident takes the time to walk up to a Public Safety Office and thank them for what they do in the community.

Pastue noted law enforcement has been under the gun nationally and how touching it is for residents to express their appreciation to officers for their service and professionalism.

Pastue advised Director Christiansen is out ill and that he will discuss the items he would have addressed. He advised the redevelopment of the old courthouse property by Balfour will not be going forward due to financial issues. He stated as a result, the Farmington Road Project may have to be deferred another year given the proceeds from the Balfour Project will not be available to put into Capital Funds. They will be meeting with SEMCOG and MDOT to see if the grant for the Farmington Road Project can be deferred for another year.

10.COUNCIL COMMENT

Cowley stated that parking is a consistent issue that needs to be addressed and

that a strategy needs to be implemented. He was not unhappy that the Balfour Project on the old courthouse property did not go forward as he didn't feel that was the right use for the property. He noted the Flander's site will bring in 33 homes and taxpayers.

Scott said he was happy to see that over the last few weekends the ice rink has been fairly crowded. He hopes other businesses are able to take advantage of people being in the downtown and display what goods they have to offer to visitors.

Galvin reported that last week he along with Councilwoman McShane and Pastue went to the Georgetown University roll-out at the Costick Center on how to conserve energy at home. He advised a number of communities are participating in the Georgetown University Energy Prize and that the cities of Farmington/Farmington Hills are semifinalists with a chance to win \$5,000,000. Farmington could then be marketed as a green eco-friendly community.

MONTHLY REPORT JANUARY 2015

5K COMMITMENT RUN

On January 1st dayshift officers assisted with the Lifetime Fitness 5K Commitment Run in which there were approximately 500 participants. The event was successful without any reported incidents.

IDENTITY THEFT

On January 2nd a Chestnut Street resident reported that he noticed fraudulent charges on his Vibe Credit Union account while checking his online banking. The resident called Vibe to report the matter and learned that there were more pending charges from this date. The resident was still in possession of his card, but the number had been used at several stores in Farmington Hills, Ann Arbor and Livonia. Surveillance videos have been requested from all of the stores where fraudulent purchases were made and a Family Dollar cashier provided a description of a possible suspect and his vehicle.

LARCENY

On January 2nd, at 8:06 p.m., a resident of Drakeshire Apartments came to the front desk to report his license plate had been changed. The commander checked the license plate in question through LEIN and learned that it was registered to another resident of Drakeshire Apartments. The commander checked that subject through CLEAR (police reporting system) and learned that his vehicle had been stolen in December. The report indicated that the vehicle was recovered in Detroit after it had been involved in a crash and abandoned. Both license plates were for the same year, make and model vehicle. The license plate was removed from the vehicle and placed into the property system. The second license plate was entered into LEIN as stolen.

POSSESSION OF MARIJUANA/OPERATING WHILE INTOXICATED

On January 3rd, at 1:44 a.m., an officer stopped a vehicle on Grand River near Blanchard Boulevard for speeding. Upon contacting the driver the officer noted an odor of intoxicants and Marijuana emanating from the vehicle. The driver admitted to possessing Marijuana and drinking four beers at a friend's house. The driver failed sobriety tests and had a preliminary blood alcohol level of .14. The officer located Marijuana inside the vehicle. The driver was arrested and lodged in the Farmington jail until sober. The driver was also in possession of \$1,240 in cash, which was forfeited.

ASSIST OTHER GOVERNMENT AGENCY

On January 3rd this department assisted Consumers Energy throughout the day with traffic control at Orchard Lake Road and Shiawassee due to a gas leak in the sewer system that stretched across Orchard Lake Road.

POSSESSION OF MARIJUANA

On January 4th, at 3:52 a.m., an officer stopped a vehicle on Farmington Road near Freedom Road for an equipment violation. The officer detected the odor of Marijuana emanating from the vehicle. When questioned about the odor, the occupants admitted they were in possession of Marijuana. The vehicle was searched and officers located two different sources of Marijuana. The driver and occupant were both arrested for Possession of Marijuana and lodged in the Farmington jail until they could post bond.

HARASSING COMMUNICATIONS

On January 5th an employee of an apartment complex on Farmington Road came to the station to report two residents who have been harassing her at work. The employee states that while performing her job duties, two residents tried to hug her and talk to her. She also stated that one of them has sent her explicit text messages. She no longer wants them to contact her. She was provided with information on how to obtain a Personal Protection Order.

FELONY WARRANT

On January 5th, at approximately 9:45 a.m., an officer on patrol stopped a vehicle in the area of Grand River and Orchard Lake Road for turning right on red where prohibited. Further investigation revealed that the driver had a warrant for his arrest out of Oakland County for being in possession of Cocaine. The driver was arrested on the warrant and housed at the Farmington jail.

SUSPICIOUS PERSON

On January 6th a resident in the 36400 block of Saxony called to report that an unknown male was knocking on the back door wall of the residence. The occupant went to a different part of the house and called the police and was unable to obtain a description of the person. Officers checked the area and did not locate anyone. Officers also checked the back of the residence and found nothing disturbed.

SUSPICIOUS PERSON

On January 6th a resident in the 35800 block of Briar Ridge called to report an elderly male carrying a snow shovel approached them to shovel snow. The resident found this odd because the person did not go to other homes in the area but only approached them while they were getting ready to leave. When they declined, the person left the area on foot into the subdivision. Officers checked the area and did not locate anyone.

ODOR INVESTIGATION

On January 7th, at approximately 4:45 a.m., officers and Engine 3 were dispatched to a residence on Birchwood for an odor investigation. Upon arrival officers checked the

home and noted a chemical odor in the home. Officers were unable to determine the origin or cause of the odor, noting that it appeared to be an electrical burn odor. Officers checked the entire home with the thermal imaging camera and the gas monitor with no indication of any fire. The homeowners were advised to have their electrician test the home's electrical system and to contact this department should the odor get worse.

DISORDERLY PERSON

On January 8th, at 3:27 a.m., officers were dispatched to a gas station on Grand River near Power Road for the report of a disorderly patron. Officers arrived to find the suspect vehicle leaving the area. Officers stopped the vehicle and made contact with the driver. The driver stated that he had a verbal altercation with the clerk over an item for sale. The driver stated that the clerk was upset and said that she was "going to make him her slave." He then told her to "get lost" and he left. It was confirmed with the clerk and she stated that she does not want the subject to return. The driver agreed and was released.

ASSIST OTHER LAW ENFORCEMENT AGENCY

In the morning hours of January 9th, Farmington officers assisted Farmington Hills with several vehicle spin outs on M-5 between Orchard Lake Road and Grand River. The freeway was closed for a short time to allow salt crews from Oakland County to salt the freeway.

LARCENY

A resident from Drakeshire Apartments came to the station to report a package that was stolen from outside his apartment door. The resident was on vacation when a package was delivered from UPS. Upon his return he confirmed the package was delivered by UPS but none of his neighbors saw the package outside his door. It is believed an unknown person took the package shortly after it was delivered.

FIRE ALARM

On January 10th, at approximately 9:40 p.m., officers were dispatched to Our Lady of Sorrows Family Center for a report of a fire alarm. Upon arrival it was learned that the alarm was tripped when someone had accidentally leaned up against the alarm. The alarm was reset and officers cleared the scene.

SUSPICIOUS CIRCUMSTANCE

On January 10th, at approximately 10:10 p.m., officers were dispatched to the Zap Zone for a report of a larceny of a cell phone. Upon arrival officers learned that the owner of the cell phone had left her phone in the bathroom and had forgotten it there. When she returned looking for the phone, she noticed it was missing. The officer took the report and left the scene. Approximately an hour later the officer was contacted by management who advised that they had found the cell phone in the building.

ODOR INVESTIGATION

On January 10th, at approximately 10:39 p.m., officers were dispatched to the area of

Grand River and Orchard Lake Road for an odor of gas. Upon arrival officers checked the area and noted no odor.

WARRANT ARREST

On January 10th, at approximately 11:58 p.m., officers were dispatched to Valley View Condominiums for a report of a disorderly intoxicated visitor who is refusing to leave. Upon arrival officers met with the reporting person who advised that he had allowed his homeless friend to spend the night, but that his friend had consumed so much alcohol that he is becoming irate and disorderly. The reporting person wants his friend to leave, but his friend is refusing. Officers checked the friend's name through LEIN and noted that he had a child support warrant for his arrest out of the 6th Circuit Court. The Oakland County Sheriff's Office was contacted who advised that they wanted the man. The man was arrested on the warrant and transported to Maple and Haggerty where he was turned over to an Oakland County deputy.

OPERATING WHILE INTOXICATED (OWI)

On January 11th, at approximately 1:20 a.m., a commander on patrol noticed a vehicle speeding on Drake Road between Grand River and Freedom Road. The vehicle then disobeyed the red light at Drake Road and Freedom, sped on Lytle Street, and crossed over the double yellow line on Gill Road near Nine Mile. The vehicle was stopped in the area of Nine Mile and Cass Street. Upon approaching the driver, the commander noted that the driver had chewing tobacco in his mouth and was attempting to smoke a cigarette at the same time. The driver exhibited signs of intoxication but denied drinking. The driver failed several sobriety exams and refused to take a breath test. The driver was arrested for OWI and a search warrant was obtained for the driver's blood. The driver was housed at the Farmington jail.

ANIMAL COMPLAINT

On January 12th, at approximately 7:21 a.m., an officer responded to Chesley Drive for the report of an injured goose. Upon arrival the officer found a swan with an injured leg. Oakland County Animal Control responded to take control of the protected bird and advised that it would be going to their veterinarian.

FIRE ALARM

On January 12th, at 12:33 p.m., officers along with Engine 3 responded to a business in the downtown center which is under reconstruction. One of the workers accidentally broke a fire suppression sprinkler head off therefore causing an alarm. Officers were able to stop the flow of water and assured that somebody would be on fire watch until the system could be repaired.

CREDIT CARD FRAUD

On January 12th, at 7:59 p.m., an officer was dispatched to the Verizon store on Grand River reference a fraud complaint. A subject purchased an \$800 cell phone in a business name. He provided a Green Dot credit card for the purchase. He contacted the credit card company for approval and gave personal information to Green Dot. The purchase was authorized by Green Dot and the subject left with his new phone. The

subject then reported his credit card stolen and a stop payment was put on his Green Dot card. Verizon contacted the subject on a second phone line. The subject refused to speak with Verizon representatives and disconnected his second phone number. The Detective Bureau has subpoenaed phone records and obtained video evidence.

FELONIOUS ASSAULT

On January 12th, at 8:03 p.m., officers were dispatched to Drakeshire Apartments for the report of an assault with a baseball bat. An Indian male stated that he was walking up to his apartment door when he was approached by two black males. One black male was described as light skinned, twenty-five years old, 140 pounds, wearing a grey hooded sweat shirt without a logo. The suspect was armed with a broken baseball bat. Nothing was said before an unprovoked attack. The victim was struck in the face with the bat. The victim yelled for his brother, who was inside, to help him and he tried to hit the suspect in self-defense. The suspect then fled north toward Grand River. A K9 was called to the scene but a track was not successful. Officers canvassed the area and made contact with multiple businesses. A possible suspect may have been identified utilizing security video in the area.

<u>Follow-up:</u> On January 23rd detectives interviewed a twenty year old Farmington woman and an eighteen year old Farmington Hills man who were being held at the Farmington Hills Police Department jail pending charges for a carjacking they committed in the Fairmont Park Apartments (area of Nine Mile and Drake, Farmington Hills). Farmington investigators learned that circumstances of the Fairmont Apartments incident was similar to the Drakeshire incident. Investigators interviewed the woman who refused to answer questions. Investigators then interviewed the male who confessed that he and his accomplice, the female, intended to steal the Drakeshire victim's car after assaulting him, however, they were unable to carry out their plan because the victim unexpectantly fought back. The male was subsequently charged with attempted carjacking. He and his female accomplice are currently lodged in the Oakland County jail.

FRAUD

On January 13th a Cass Street resident reported that she received a phone call from a man claiming to be an attorney that was representing her granddaughter in a drunk driving case in Atlanta, GA. The man advised that the bond was \$2700 but that if she was able to post the bond immediately via Western Union that it would only be \$1370. The woman wired the money and later learned from the granddaughter that she knew nothing about the situation, that she had been at work in Grand Rapids all day and that she wasn't in Atlanta. The matter has been turned over to the Detective Bureau.

OPERATING UNDER THE INFLUENCE OF DRUGS SECOND OFFENSE

On January 13th, at 10:48 p.m., officers were dispatched to the area of Grand River and Drake Road for the report of a subject slumped over the steering wheel, blocking traffic. The vehicle was located by a sergeant, who had to pound on the window to wake the driver. The driver had an odor of intoxicants on his breath and was on his way home from a local bar. The driver was given sobriety tests which he failed and had a

preliminary breath alcohol level of .05. The driver was in possession of Adderall for which he is not prescribed. The driver admitted to taking multiple pills throughout the day. The driver was arrested for Operating Under the Influence of Drugs (OUID). This was his second offense for OUID.

LARCENY BY CONVERSION

On January 14th an officer responded to the 32000 block of Grand River Avenue for a report of a fraud. The victim needed repairs done to his vehicle to get it running. The victim used the website, Craigslist, to look for someone who would be willing to do the work. The victim made contact with someone willing to do the work and both arranged a time, date and price for the work. The person arrived at the victim's residence and the victim handed over the agreed upon payment in cash. The person then stated he needed to get some supplies to complete the job and left. The victim called the person back a couple hours later since he did not return and found the phone was disconnected.

LARCENY IN A BUILDING

On January 16th, at 1:53 p.m., an officer responded to Tubby's Submarines for the report of a larceny. Employees advised that sometime during the busy lunch rush, unknown person(s) entered their office area and stole an employee's wallet which contained \$300 as well as a total of \$185 out of a bank deposit bag and a cash box. Tubby's does have a video surveillance system, but it was out of service at the time of the theft. The following day, the wallet was found in the parking lot of Pep Boys in Livonia with only \$25 missing as the rest of the cash was hidden in another compartment. The White Castle next to Pep Boys has video surveillance of the parking lot where the wallet was found. The Detective Bureau will be following up with White Castle in order to develop a suspect in this matter.

FALSE IDENTIFICATION, FELONY PROBATION WARRANT, DRUG PARAPHERNALIA

On January 17th, at 3:06 a.m., a commander was conducting an Apartment Watch inside Drakeshire Apartments. The commander observed a vehicle, without lights on and the engine off, blocking a driveway. The vehicle was occupied by a male and female. The commander made contact with the occupants who could not explain why they were in the lot. The female stated that she was here to stay with a subject named "Scott", but she did not know what apartment was his or anything else about him. She stated that he was going to text her when he was ready for her to come inside. The male stated that he was only driving the female to visit a friend, but he could not elaborate on the matter. The commander obtained identification from the male driver but the female stated that her identification had been stolen. She provided a name verbally but that name could not be located in LEIN or SOS. The female appeared under the influence of drugs. She was removed from the car and questioned outside. After a lengthy conversation and investigation, the female finally admitted who she was. Her correct name was located and officers learned that she had a felony warrant out of Wayne County for possession of Cocaine and Heroin. She was an absconder from probation. The female was arrested for providing a false name to officers and the

warrant. The vehicle was searched and on the floor of the passenger seat there was a used heroin needle. The male stated that she had shot up Heroin a few hours earlier. The female was lodged in the Farmington jail pending arraignment, and the male was released.

OPERATING WHILE INTOXICATED (OWI)

On January 18th, at 2:39 a.m., an officer observed a vehicle traveling the wrong way on Thomas Street at Farmington Road. The officer stopped the vehicle and made contact with the driver. The driver stated that she was on her way home from a party on Eight Mile and realized that she had too much to drink. She was looking for a place to park her car and then she was going to call her husband to pick her up. The female was given field sobriety tests which she failed. A preliminary breath test result was .10. The driver also had an open bottle of liquor inside her car. The driver was arrested for OWI and lodged in the Farmington jail.

FALSE IDENTIFICATION TO A POLICE OFFICER

On January 18th, at 12:40 p.m., officers responded to Valley View Condominiums for the report of a possible domestic violence situation in progress. Upon arrival officers could hear loud arguing and knocked on the door. Upon making contact with the occupants of the condominium it was learned that there was no physical altercation, only a verbal argument. While interviewing the subjects, the male half claimed to have no formal identification on him so it was obtained verbally and ran through LEIN/SOS for verification. When that name returned with no record, the officers learned the correct name from the female half. The male was then arrested for False Identification to a Police Officer as well as for two outstanding warrants.

CARBON MONOXIDE (CO) ALARM

On January 18th, at 2:39 p.m., officers responded to a Cass Street address for the report of a CO detector going off. Officers utilized a multi-gas detector to check the home which found no signs of CO. Residents were advised to call back should they show any signs or symptoms of CO sickness.

On January 22^{nd} , at $1\overline{2:10}$ p.m., officers along with Engine 3 and callback personnel responded to the Farmington Oaks Apartments for the report of smoke in the hallway. Upon arrival it was learned that the source of the smoke was a careless cook and that

there was no fire. An exhaust fan was utilized in order to clear the smoke from the building.

TRESPASSING

signs of intoxication. The man failed several sobriety exams and was arrested for OWI. The man was transported to the Farmington jail where he submitted to a Datamaster breath test. The man had a blood alcohol content of a .12.

Background:

City Administration is recommending that the existing agreements with the Civic Theater General Manager and Market Master for the Farmington Farmers and Artisans Market be extended for one additional year. The term of the agreement for the Civic Theater General Manager is scheduled to expire on June 30, 2015. There is an option for two one-year renewals. The term of the agreement for the Market Master is scheduled to expire on December 31, 2015. It also has an option for two one-year renewals.

There are two primary factors in presenting the recommendation to extend the agreements for one additional year before the renewals are considered. The first is that this would provide the new City Manager ample time to evaluate whether to exercise the renewal option in the agreements. The first year is always a challenge for a new chief administrative officer in local government as they need to assess the organization, evaluate current and future issues, and understand local politics. The second reason is that it sends a strong message of support from the City Council to the Civic Theater General Manager and Market Master. Both operations are profitable, well received and supported by the community, and they operate consistent with our family-oriented community.
