- Farmington Observer home articles: Commissioner Stacey will have the article on the Rehbine's house ready for publication soon. Gundlach sent the Observer a captioned photo from last year's luminary display on Oakland Street. She also plans to provide an old picture of her house and a brief paragraph for a new feature, Pictures of Old Farmington, in the Farmington Press.
- ☑ **Goals of the Commission:** We will develop goals for the Commission so that we can speak as one voice. All commissioners should bring a "wish list" of what they would like the Commission to accomplish in 2014 to the January 24 meeting. Also ideas to promote a positive image for the District.
- Study Session: We will meet on Wednesday, January 8, at Commissioner Weimar's house for a midmonth Study Session to go over criteria and goals. Some ideas include an annual joint meeting with the Planning Commission and Zoning Board and developing a specific set of criteria for the Building Department so they know exactly what kind of renovations/repair we want to review.
