<u>Description:</u> Consideration to Hire a Mansion Director for Governor Warner Mansion on a Contract Basis

Requested Action:

Discuss authorizing the City Clerk to hire a Mansion Director for Governor Warner Mansion on a contractual basis. The Mansion Director's position is to be funded through Mansion revenues from events, sponsorships and grants.

Background:

City Administration is requesting Council to authorize the hiring a Mansion Director on a contract basis similar to what is being done with the Civic Theater and the Farmers Market. The Mansion Director's position would be funded through Mansion revenues from events, sponsorships and grants. An amount sufficient to pay for the position for one year has already been saved through prior events and activities.

In early 2009, at the request of the City Manager, the Clerk's Department agreed to oversee operations of the Mansion on a temporary basis until other arrangements could be made. Prior to this request, the Mansion had been run by volunteer Dick Carvell who passed away in late 2008. At that time, only a few events were held at the Mansion, along with the days the Mansion was open to the public for tours.

The Clerk's Department established a Mansion Committee that same year to help facilitate a higher and better use of the Mansion. As a result, each year the number of activities and events has increased along with higher revenues. Also, reservations for use of the Mansion grounds, primarily for weddings and photography, over the last six years have risen. In addition, the "Friends of the Mansion", a 501(c)3, was formed to further pursue funding for the Mansion.

As the activities and use of the Mansion increased, the support of the Clerk's department increased as well. In the last couple of years, on average the Deputy Clerk was spending 50% of her time on Mansion activities and the Clerk approximately 25%. We are facing a Presidential election year with three elections making it more imperative that a change take place.

We believe that a Director dedicated to the administration of the Mansion would be able to increase revenues through sponsorships, grants, increased activities, and cost containment. The responsibilities of this position would also include, but be not limited to: coordinating volunteers, maintaining the Museum collection, annual budgeting, planning and scheduling events; managing publicity and public outreach.

The contract would require the Director to increase revenue sufficiently to cover his/her salary. The goal would be to not only increase revenues to cover the Director's salary, but the long term goal would be to work towards a self-sustaining Mansion.

A RESOLUTION OF THE FARMINGTON CITY COUNCIL TO AMEND TRAFFIC CONTROL ORDERS

The Farmington City Council resolves that the Traffic Control Order issued by the Director of Public Safety of the City Of Farmington, dated February 1972, is hereby amended as follows: as provided for in Section 28-1153 of the Uniform Traffic Code, as adopted in Section 31-51 of the City Code of the City Of Farmington, and Section 31-60 of the City Code of the City of Farmington.

Chapter 14 – Municipal Parking

AMEND:

Section 14.4 – Municipal Lots (north side) 33200, 33304, 33306, 33308, 33312, 33316, 33318 Grand River Avenue.

(a) Parking shall be limited to a maximum of three (3) hours between 9:00 a.m. to 9:00 p.m., Monday through Saturday, in the entire municipal parking area (excluding the six (6) spaces directly north of 33332 Grand River and the eleven (11) parking spaces located adjacent to the west side of 33224 Grand River – Village Shoe Inn), behind 33200, 33304 (including the six (6) angled parking spaces located adjacent to the east side of the building – Grace Insurance), 33306, 33308, 33312, 33316 and 33318 Grand River Avenue.
