# INTRODUCTION: PAMELA O'NEIL – WATERCOLORIST – EXHIBITING ARTIST Mayor Mitchell introduced Pamela O'Neil, watercolorist, whose artwork is currently on display in Farmington/Farmington Hills City Halls. Ms. O'Neil spoke about her artwork and expressed appreciation to Council for their acknowledgment of her work. Council presented a proclamation to Ms. O'Neil in recognition of her contribution to the art world.

#### PETITIONS AND COMMUNICATIONS

**REQUEST FOR FENCE VARIANCE AT 23060 MANNING BY PROPERTY OWNERS MARK WELLS AND LAURA EVEN-WELLS.** Administration advised that property owners, Mark Wells and Laura Even-Wells, who live at 23060 Manning, have requested permission to construct a fence on their corner lot that would require a variance under Chapter 3, Section 8, Subsection (1)a. Administration further advised that to date, Council has only allowed replacement fences in similar situations.

Mr. Wells was present to explain his reasons for the request and to answer questions.

In response to a question from Council, Mr. Wells stated that there is enough room between the trunk of the trees and the property line to install a fence, however, the trees would need to be trimmed back. Responding to a question from Council, City Manager Lauhoff stated that the fence ordinance was designed to maintain open space areas. He further stated that there are areas in the City where it is difficult to strictly abide by this ordinance.

A motion was made to grant the variance request but died with lack of support.

A motion was made and seconded, then withdrawn, to deny the variance request.

Council member Campbell stated the proposed fence is in keeping with the character of the neighborhood. Council member McShane stated this type of decision is difficult because Council makes every effort to adhere to ordinances as written. Council member Bush also stated the need to adhere to City ordinance and she expressed concern regarding the survival of the trees on the property if they were trimmed back to accommodate the fence.

#### COUNCIL PROCEEDINGS -3-May 06, 2002

Discussion followed regarding the look and survival of the trees once they are trimmed back. Director Gushman recommended installation of the fence inside the tree line. Council member Harrison concurred with Director Gushman stating that this would be a viable option.

Mayor Mitchell noted that this request appears to be more for the convenience of the homeowner which is not necessarily a justification to grant a variance.

City Attorney Donohue suggested that Council work with the property owner to arrive at an alternate solution. City Manager Lauhoff proposed consulting with the City Planner.

<u>05-02-733</u> MOTION by McShane, seconded by Bush, to table the fence variance request at 23060 Manning until further study can be done. MOTION CARRIED UNANIMOUSLY.
