The Owner-Landlord Program for owneroccupied duplexes provides qualified landlords the opportunity to receive up to \$18,000 per unit to make needed home repairs on each unit. The owner-landlord must live in one of the dwelling units and both owner and tenant must meet the income requirements.

For both programs, there are no monthly payments, and the total loan is due and payable only when the original owner no longer lives at the property.

Oakland County staff is with you all the way from helping you apply to overseeing repair work and paying our pre-qualified contractors.

If you answer YES to the following questions, you may qualify for an interest-free deferred payment loan under the Home Improvement Program.

- Do you live in Oakland County and own your home? (The City of Lake Angelus, Novi Township, Southfield Township, Village of Bingham Farms and Waterford do not participate in the program.)
- Do you meet income requirements?
- Are needed improvements to your home eligible under the program?
- Does your tenant meet income requirements?
- Are needed improvements to your home or tenant's unit eligible under the program?
