#### 2007 PUBLIC SAFETY ANNUAL REPORT

Director Chuck Nebus presented the 2007 Public Safety Annual Report. He thanked Council for their support and involvement in the Public Safety Department.

Nebus reported Part "A" serious crime was down 12% in 2007. He noted a 36% increase in medical runs and an unprecedented 162 drunk driving arrests. He further noted most of the drunk driving arrests were not residents and rarely have they been drinking at licensed establishments in Farmington or Farmington Hills. He advised there were 413 car accidents last year which was a 20% increase. He stated the reason for the increase related to harsh weather conditions.

Nebus noted the department made a significant 886 arrests which demonstrates the officers are working hard and keeping crime down.

Nebus pointed out there were two severe storms in 2007 that resulted in down wires, fires and mutual aid requests. He stated the Public Safety Officers performed brilliantly during those storms. He noted there were 148 fire runs last year.

Nebus reported the Public Safety Department (DPS) now provides 66 different community policing programs.

Nebus noted the recent collaboration report confirmed the efficiency and effectiveness of DPS including the incredible response times.

Councilmember Wiggins noted Part "A" or serious crime was the lowest in five years and Parts "B" & "C" self-initiated and service calls were up which means not only are the officers doing a fine job in keeping crime down, but are responding to more calls for service.

Councilmember McShane stated DPS has done a phenomenal job of containing costs while providing excellent service with the same number of officers doing both police and fire. She noted the personal attention residents receive from the department.

Nebus noted it has been 25 years since any staff has been added to the department.

#### COUNCIL PROCEEDINGS -3-June 16, 2008

Councilmember Buck congratulated Director Nebus and his staff on their excellent performance and providing a terrific report. He noted the program providing e-mail crime alerts is a wonderful way of engaging the community. He stated the department's record on solving crimes is impressive. He recognized the value of mutual aid and cross community programs.

Councilmember Wright stated one of the more important aspects of a quality community is safety. He further stated this community is known for its safety due to the talent and quality of the DPS. He noted the increase in petty crime and speculated its relationship to the current economic conditions.

Mayor Knol thanked Director Nebus for his excellent report. She questioned the significant increase in medical runs and wondered if this could be a trend. Nebus responded it could be related to an aging population, but was unsure of the exact cause.

Mayor Knol thanked Director Nebus for all his efforts in providing a safe community. She encouraged DPS to be vigilant in providing the schools with a safe environment for children to learn.

#### PUBLIC COMMENT

Hank Borgman, Farmington resident, discussed positive experiences he has had with the Department of Public Safety. He noted the high regard the community has for the department.

Mike Rogers, Oakland County Commissioner, announced a town hall meeting would be held on July 9<sup>th</sup> at 7:00 p.m. at the Maxfield Training Center regarding the proposed millage increase by the Oakland County Zoological Authority.

#### COUNCIL COMMENT

Councilmember McShane asked how the City weathered the recent storms. Director Gushman responded the City had a minimal amount of clean-up compared to surrounding communities. Director Nebus stated there were no emergencies of any magnitude or fire runs.

Councilmember Wright asked if the City had considered adopting a flex work schedule similar to Oakland County. Pastue responded City staff is currently reviewing options including working nine days in a two week period.

Wright asked regarding a crosswalk on Farmington between Grand River and Alta Loma. Gushman responded that he has been in discussions with MDOT regarding reimbursement for the cost of the Grand River crosswalk. He stated the Oakland County Road Commission would like a letter from the City identifying where the crosswalk will be placed on Farmington Road.

Mayor Knol asked about signage related to the crosswalks. Director Nebus stated the City is waiting for approval from MDOT to place the A-frame signage on the Grand River crosswalks. He will seek approval from the Road Commission for signage when the crosswalk is installed on Farmington Road.
