APPROVAL OF AGENDA

BOARD AND COMMISSION INTERVIEWS

Council interviewed Susan Warner and Scott Stevenson for positions on the Farmington Area Arts Commission.

Council discussed the appointment process for the two Commission openings. Council concurred to make only one appointment that evening to allow Scott Stevenson the opportunity to attend a Commission meeting.

SWOCC ENCODER

City Manager Pastue advised an encoder is a means of communicating the AT&T signal once it is received from SWOCC. He stated historically all public access, education and government (PEG) channels were transmitted through Brighthouse which was the only cable provider. He advised the new AT&T Franchise is paying additional franchise fees for PEG channels which need to be made available to their customers. He stated the encoder is necessary to make this possible.

Responding to a question from Wright, Pastue stated there would be no justification for *not* providing this service to AT&T customers.

Responding to a question from Wiggins, Pastue stated the number of customers for each cable provider is unknown.

Knol advised customers of AT&T are entitled access to PEG channels given AT&T is paying the applicable fees.

SPECIAL MEETING -2-September 21, 2009

Council expressed support for the purchase of the encoder.

Pastue advised formal approval by Council was unnecessary since the amount is less than \$10K which is under his authority. He noted, however, he will ask for a budget amendment approval for this purchase.

MICHIGAN SUBURBS ALLIANCE PARTICIPATION ENERGY AGREEMENT

Due to time constraints, Pastue requested delaying discussion on the Michigan Suburbs Alliance Participation Energy Agreement until the October 5, 2009 meeting.

OTHER BUSINESS

No other business was heard.

PUBLIC COMMENT

No public comment was heard.

COUNCIL COMMENT

Buck noted in the August 2009 minutes, Council was scheduled to discuss SMART this month. Pastue responded it would be placed on the October agenda.

Buck advised the 2010 Census should also be placed on an upcoming agenda. Knol pointed out this discussion should be part of the Public Safety grant position for the apartments.

Discussion followed regarding Council's contribution to the Downtown Scarecrow Building Contest.
