Description: Grand River on Street Parking Study Results

Background:

Following the December 12, 2014 Road Diet Study, the City of Farmington approached MDOT to research the potential of adding on street parking on eastbound Grand River east of Grove Street. MDOT carefully considered this proposal, and advised the City, this could only be considered if an additional traffic count study was performed per MDOT standards. This study was delayed several months due to the lack of funding for the project.

It was necessary to perform the traffic counts under four different conditions. Both in the morning peak hours and the evening peak hours.

Count #1: No school in session, all lanes open

Count #2: No school in session, eastbound lane closed Count #3: School in session, eastbound lane closed

Count #4: School in session, all lanes open

OHM staff trained and supervised City of Farmington personnel to conduct the traffic counts. Traffic counts were recorded for Grand River Avenue at Farmington Road and at Grove Street.

Matt Parks, P.E. from OHM Advisors has provided a memo of the traffic study results. The study results and additional data will be added to the 2014 Geometric and Operations study (Road Diet).

Re: Grand River Road Diet Data Results

The conclusions of the 2014 Road Diet Study on Grand River between Shiawassee and Orchard Lake Road indicate the potential for roadway narrowing between Grove Street and Mooney Street. This narrowing would eliminate the second eastbound through lane, providing space for additional street enhancements. In order to better define the impacts of the removal of this travel lane a trial closure was requested by MDOT. OHM coordinated with MDOT and traffic data collected and reviewed.

This trial closure occurred between Grove Street and Orchard Court. The lane closure was accomplished using construction drums to simulate the existing travel lane converting into on street parking. Traffic count data was collected by City Staff members on four Tuesdays in August and September. Data was collected at the intersections of Grand River and Farmington and Grand River and Grove. Volume and Queuing data was collected under the following conditions.

- Lane Open, Schools Closed (summer conditions)
- o Lane Closed, Schools Closed (summer conditions)
- o Lane Closed, Schools Open
- o Lane Open, Schools Open

This collected data was processed and reviewed by OHM Advisors. Traffic volumes with the lane closed were within 5% of the volume with the lane open. This is within the normal daily traffic fluctuations and indicates that the closure of the lane did not cause a substantial number of people to alter their routes.

The queuing data collected included queue counts at multiple points during each peak period (AM and PM) count. The average queue length with the lane closed was within +/- 2 vehicles of the queue length with the lane open. This is within the normal daily traffic fluctuations and indicates that the closure of the lane is not substantially increasing the gueues at these intersections.

The results of the trial closure are consistent with the results from the 2014 Road Diet Study traffic models. While the trial closure was limited to between Grove Street and Orchard Court, it is anticipated that extending the closure further east would have similar minimal impacts. Based on this we are prepared to submit the raw data to MDOT and start preliminary discussions with them on how to incorporate various <u>road diet pavement markings</u> in the upcoming 2017 mill and overlay project that MDOT has programmed. This provides an excellent opportunity to test a road diet prior to spending significant money on a reconstruct which is being scoped but has no official target date (anticipated being around 2028 should funding become available).

Background:

On or about October 1976, Farmington City Council authorized the City Manager to enter into a mutual understanding between the City of Farmington and the First Methodist Church located at 33112 Grand River.

A letter received on July 16, 1990 from the Church requesting maintenance to the parking lot included seal coating and striping.

Attached are two estimates from a Contractor for repairs to the parking lot. Historically minimal maintenance has been performed in this lot. A third estimate has been received verbally but not in writing.

Several other contractors were contacted for quotes, but due to the time of the year are not able to complete the work this season.

BE IT RESOLVED: That the Farmington City Council, pending investigation as to a possible contract between the Methodist Church and the Farmington Public School District, hereby authorizes the City Manager to enter into a mutual understanding between the City and the First Methodist Church of Farmington for the use of the Methodist Church Parking Lot on the northeast corner of Thomas Street and Warner Street. The terms of the Understanding shall be as follows:

IT IS UNDERSTOOD THAT: The Church parking lot contains approximately fifty (50) parking spaces;

The City of Farmington requests the use of approximately forty (40) parking spaces six days a week during normal business hours of the Central Business District;

The understanding shall be in the form of a mutual understanding, without the formality of a signed contract; in accordance with the Book of Discipline of 1976, the United Methodist Church.

The City agrees for the use of the parking spaces, to assume the responsibility of maintaining the parking lot, including filling holes, the annual painting of the parking stripes, maintenance of the guard rail and parking blocks, the maintenance and cleaning of the storm drain, and the City shall insure the Church against public liability arising from the use of the parking lot for public parking; further, if major repairs are necessary, the City shall negotiate with the Church as to cost sharing for major repairs or reconstruction of the lot;

The City shall be responsible for all snow removal on this parking lot as well as the parking spaces located immediately north of the Church building;

The City shall arrange the use of the lot so as to provide assigned parking spaces for the various owners and their employees of the businesses on the north side of Grand River to provide for the parking of their vehicles on the northery section of the lot, leaving the southerly ten spaces free for Church patrons, senior citizens and other visitors.

It is mutually understood that the understanding shall be reviewed annually to determine if any problems have arisen which should be the subject of an amended understanding and that either party may terminate this understanding by notifying the other party, in writing, 120 days prior to the termination.

Re: Parking Lot, Methodist Church

Mr. Glen Dusek of the church building committee has contacted me regarding the striping and maintenance of the parking lot at the northeast corner of Thomas and Warner. It seems that the church is having some exterior maintenance work done, and, in the course of estimating the cost, sought estimates on restriping the parking lot south of Thomas Street. Their contractor suggested that the lot north of Thomas Street also should be seal coated and striped; he would do the job for \$1,948.00.

As you know, in October, 1976 the city council assumed responsibility for the maintenance of the parking lot. I have looked at the lot. It does need striping. In my opinion there are several cracks that should be sealed and about three spots that require more extensive repair. Will you inspect the lot and offer your opinion about the following.

- 1. Is seal coating an effective process? If so, is other work required before seal coating? Can we do the repairs, or should they be contracted out.
- 2. Is there a better option than seal coating?
- 3. Can we do the striping?

There are some holes in the road, near the north entrance to the lot, that should be filled.


Kevin,

Thank you for meeting with me this morning. I am copying this to our Trustee Chair, Karl Miller, so that he has some understanding of what we discussed.

I think it is helpful that we now have the Council Minutes from 1976, indicating the friendly agreement between the city and the church. It mentions approximately 50 spaces, 40 of which we make available to the city during the week, in exchange for the city maintaining the lot—plowing in the winter, repairing and restriping as necessary.

We look forward to hearing from you as to what improvements you agree are required, and hope that an August work date will prove feasible—after the Founder's Festival, and after our Vacation Bible School, which is the last week of July. Because of the unique sharing agreement, we believe we have shared liability for any injuries in the lot, and did have several people (at least 3 this winter) who fell in that lot—due at least in part to the very uneven conditions. We look forward to its repair, and are grateful for the city's willingness to continue to partner with us.
