PUBLIC COMMENT

Hank Borgman, 34011 Grand River, requested information regarding the CDBG application. Pastue explained how the funds from the grant are distributed in conjunction with Farmington Hills.

Betty Borgman, 34011 Grand River, asked when she would be receiving a property tax receipt. Treasurer Weber responded the City does not send out property tax receipts.

COUNCIL COMMENT

Wright noted Mayor Knol did an excellent job in responding to questions from the Boy Scout Troup who were present earlier.

McShane recommended that if there is a ballot proposal on an upcoming election ballot, the City newsletter with an explanation of the proposal language should go out early enough to allow residents enough time to review.

McShane requested the Council meet to discuss options regarding the Civic Theatre.

McShane asked about the format of the city calendar. Pastue responded he will know within the next week whether or not the City will produce a calendar for next year. He stated they continue to look for sponsorship of the calendar.

Wiggins noted the City received notice from the Michigan Municipal League that Farmington was a recipient of a Loss Control Achievement Award.

Wiggins recognized the City's efforts to maintain the pedestrian crossing sign at Farmington Road and State Street.

Pastue advised the City's modification factor for Workers Compensation was .69 which means the City is better than 30% less than other communities.

Pastue further advised Director Gushman received a letter from the Road Commission for Oakland County indicating they will discuss with their legal council regarding the City's request to keep the pedestrian sign on Farmington Road.

Knol noted a second grade class from Longacre Elementary School will be displaying posters at Big Apple Bagel regarding the Streetscape Project.

Knol thanked Karen Buck for her creative efforts in creating the Council scarecrow display.

COUNCIL PROCEEDINGS -5-October 19, 2009

Knol noted the ribbon cutting for the Streetscape Project was scheduled for the following Saturday.

In recognition of her last meeting as Mayor, Knol thanked Council, City Administration and the residents of Farmington for providing the opportunity to serve. She stated her greatest accomplishment was involvement in the passage of the Streetscape Bond and the subsequent achievement of the Streetscape Project. She also cited the accomplishment of televising Council meetings and looked forward to an updated website.

Knol recognized Council's ability to work together and their respectfulness of each others opinions. She discussed the economic challenges Council is facing ahead.

Knol stated her support for Tom Buck as the next Mayor.

Knol discussed the reason this would be her last meeting as Mayor. She was selected by the American Council of Young Political Leaders to be a delegate to India for a ten-day political exchange program. In her application to this program, she had selected India as her first choice because Farmington has a large Indian population.

Council congratulated Knol on her wonderful job as Mayor.
